#### **I. EXECUTIVE BRIEF**

Motion and Title: Staff recommends motion to approve: A time extension for a Joint Participation Agreement (JPA) with the Florida Department of Transportation concerning the preparation of an Interchange Justification Report for Central Boulevard and I-95.

SUMMARY: This time extension will extend the expiration of the JPA to March 31, 2009.

**Background and Justification:** On December 17, 2002, the Board of County Commissioners approved JPA R2002-2231 with the Florida Department of Transportation (FDOT) concerning the preparation of an Interchange Justification Report (IJR) for Central Boulevard and I-95. The JPA provided for FDOT's participation in funding up to one-half of the cost of the IJR, not to exceed \$175,000. The JPA expires on September 30, 2008, and the report is not expected to be finalized until March 2009.


