I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: A Resolution to accept maintenance of Flavor Pict Road, which is a thoroughfare road, between Hagen Ranch Road and Jog Road, approximately 1.07 miles, at an estimated cost of \$5,121 annually.

SUMMARY: The developer, Winsberg Farm PUD, was required to construct Flavor Pict Road per Condition E.7 of Petition 1997-095, Resolution R-2000-1707.

District 5 (MRE)

Background and Justification: The Land Development Division issued a permit to Housing Trust Group of Florida, LLC, for the construction of Flavor Pict Road on June 27, 2005. The construction was reviewed by the Construction Coordination Division and approved on October 12, 2006. The Engineer of Record has submitted the required certification. It is estimated that it will cost \$5,121 annually to maintain this section of thoroughfare road.


