I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Change Order No. 7 with Cedars Electro-Mechanical Inc. (R2007-0273) in the amount of \$63,423 to provide additional HVAC work at the Water Utilities Department (WUD) Waste Treatment South Regional Plant in Boynton Beach.

Summary: The work consists of additional work required to complete the installation of new air conditioning systems and associated electrical for nine existing buildings using reclaimed water as the cooling medium. Modifications to the existing fire alarm systems are required by the PBC Building Department to bring the systems compliant with current code. The SBE participation in this change order is 100%. The SBE goals are 15%. This change order is being sent for Board approval since the total time extension for the contract exceeds 90 days. The total construction duration for the additional work is 60 days. This work will comply with all applicable local, state, and federal codes and regulations. (FD&O Admin) Countywide/District 5 (JM)

Background & Justification: The air conditioning systems have been completed and operational since January 2008. The final inspection by the PBC Building Department identified code deficiencies with the existing fire alarm system that were not identified during the permit approval process. This change order provides the minimal level of modifications identified that will both satisfy the Building Department and that WUD was willing to fund.


