I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

A) Contract with West Construction, Inc., for the construction of Phil Foster Park Multi-Purpose Building in the amount of \$1,042,000, and

B) Change Order No. 1 to the Contract with West Construction for the Palm Beach County Sheriff's Office (PBSO) Marine Unit Building in the amount of \$451,570.

Summary: The contract for Phil Foster Multi-Purpose Building will authorize construction of a two story building to provide concession space, a multi-purpose meeting room, and public restrooms. This project was originally bid with a second floor shell space for a future tenant buildout. Subsequently, the Board approved a transfer of funds for the buildout of the second floor for PBSO Marine Unit. Approval of Change Order No. 1 will authorize the buildout. The SBE goal for this project is 15%. West Construction, Inc.'s base bid includes a participation of 22% and including this Change Order a total of 22.5%. The contract time is 365 days to substantial completion. (Capital Improvements Division) District 1 (JM)

Background and Justification: Improvements to Phil Foster Park were completed in 2007, including new public pavilions, a restroom/life guard building, an equipment maintenance building and a two story restroom building. This building will provide supplementary facilities including space for a concession for water sport activities, restrooms, and a public meeting room for educational purposes in close proximity to the existing docks. This project was bid with a second floor shell space for a future tenant build out. Subsequently, an agreement between Parks & PBSO was reached to allow the Marine Unit to relocate to Phil Foster Park and on May 20, 2008, the Board approved a transfer of funds for the design and construction changes. Bids for this project were opened on July 16, 2008, with West Construction, Inc., being the lowest responsive bidder. This project will be covered under the County's Master Builder's Risk insurance policy.

Change Order No. 1 is being funded from Law Enforcement Impact Fees. Proceeding in this manner (buildout of second floor) allows the County to realize a 40% savings over a stand alone building.




