RE: Extension Request for Expenditure of HHRP Funds for Fiscal Year 2005/2006

Dear Mr. Lowery:

The Florida Housing Finance Corporation is in receipt of your correspondence dated May 27, 2008 requesting an extension of the expenditure deadline for the HHRP Allocation for Fiscal Year 2005/2006.

According to Rule 67ER06-45 (9), which governs the HHR program, exceptions to the timeframe, are allowable under certain conditions, as detailed below:

Eligible counties and eligible municipalities shall have two years to encumber funds for their intended use, and an additional year to fully expend the funds. If a local entity shows that it has been unable to fully expend the funds after this period, it may request a one year extension to this timeframe pursuant to subparagraph 67-37.005(6)(f)2., F.A.C.

Florida Housing believes that your current situation warrants an extension based on the reasons presented in your correspondence. Therefore, your deadline to expend funds for the 2005/2006 fiscal year is extended by twelve (12) months. The new deadline is June 30, 2009. We do stipulate, however, as a part of this extension, that the County provide the Corporation a written monthly update outlining the status of the current spending.

Please keep in mind that you are still required to submit an annual report on September 15, 2008.

The Corporation commends your continuing efforts to benefit the citizens of Florida through the HHR program. If we can be of assistance to you in the administration of your HHR Program, please don't hesitate to contact us.
