I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Budget Transfer of \$380,000 within the \$25M GO Parks and Cultural Improvements Bond Fund - 2003 from New Boat Ramp Park/Boynton Inlet to Santaluces Park Athletic Field Improvements.

Summary: This Budget Transfer provides funding for major renovations to the athletic field facilities at Santaluces Park. These renovations include replacing sports lighting on two major league fields, providing additional bleachers, and renovating the batting cages. Funding is from the 2002 \$50 Million Recreational and Cultural Facilities Bond referendum, as amended — District 3. The District Commissioner supports this Budget Transfer. <u>District 3</u> (AH)

Background and Justification: On November 5, 2002, a bond referendum, as amended, was passed by the voters of Palm Beach County in the amount of \$50 Million for the issuance of general obligation bonds for the purpose of financing the acquisition, construction of, and/or improvements to certain recreation and cultural facilities. This project represents one such recreational/cultural project.

Funding for this project is to replace 25-year old sports lighting on two major league fields with new green technology, which will reduce electrical usage by 50%, provide a safer more well lit facility, significantly reduce recurring maintenance costs due to a warranty that covers parts and labor, and reduce light spillover into the adjoining neighborhood. The additional bleachers will accommodate the large crowds associated with tournaments held at this athletic complex. Replacement of the batting cage nets will provide for greater utility of the practice facility and ensure participant safety.
