I. <u>EXECUTIVE BRIEF</u>

Motion and Title: Staff recommends motion to receive and file: Grant Adjustment Notice amending the Florida Department of Law Enforcement's State Homeland Security Grant, for the Palm Beach County Sheriff's Office SWAT and EOD Sustainment Project, to extend the ending grant period from September 30, 2008 to March 31, 2009.

Summary: The Board of County Commissioners (BOCC) accepted this grant for \$42,455 on May 6, 2008; the original period for this grant was January 1, 2008 thru September 30, 2008 (R-2008-0812). This agenda item will extend the grant period from September 30, 2008 to March 31, 2009. The Palm Beach County Sheriff's Office (PBSO) received this award from the Florida Department of Law Enforcement (FDLE) to purchase equipment and supplies to implement Florida's Domestic Security Strategic Plan. These funds and related equipment, which have been approved by FDLE for purchase, will be used to enhance the region's and the State of Florida's SWAT and EOD capability and capacity to prevent and respond to Weapons of Mass Destruction (WMD) Chemical, Biological, Radiological/Nuclear, and Explosive (CBRNE) threats and attacks through updated technologies and equipment. The PBSO has been given an extension to allow the grant funds to be fully expended. There is no match requirement associated with this award. No additional positions are needed and no County funds are required. Countywide (DW)

Background and Justification: The Florida Department of Law Enforcement received funding from the US Department of Homeland Security, Office of Domestic Preparedness for the State Homeland Security Grant Program (SHSGP). SHSGP supports the implementation of the State Homeland Security Strategy to address the identified planning, equipment, training, and exercise needs for acts of terrorism.
