#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Change Order No. 1 in the amount of \$107,093.20, together with a 30-day time extension, to Contract No. R2008-0588 with J.W. Cheatham, LLC for construction of Haverhill Road from 45<sup>th</sup> Street to north of Northern Palm Beach County Improvement District EPB-10 Canal.

SUMMARY: Change Order No. 1 is compensation for additional cost encountered due to utility conflicts with the City of Riviera Beach Utilities.

District 7 (MRE)

Background and Justification: This change order is required to address modifications, removal, and additions required due to conflicts found during construction, and at the request of the City of Riviera Beach Utilities, as noted in the Interlocal Agreement between Palm Beach County (County) and the City of Riviera Beach, which was approved by the Board of County Commissioners on September 9, 2008. The Contractor, J.W. Cheatham, LLC, has proposed compensation of 30 days and \$107,093.20 for this additional work. The City of Riviera Beach has agreed to fully reimburse the County \$107,093.20 for this change order.


