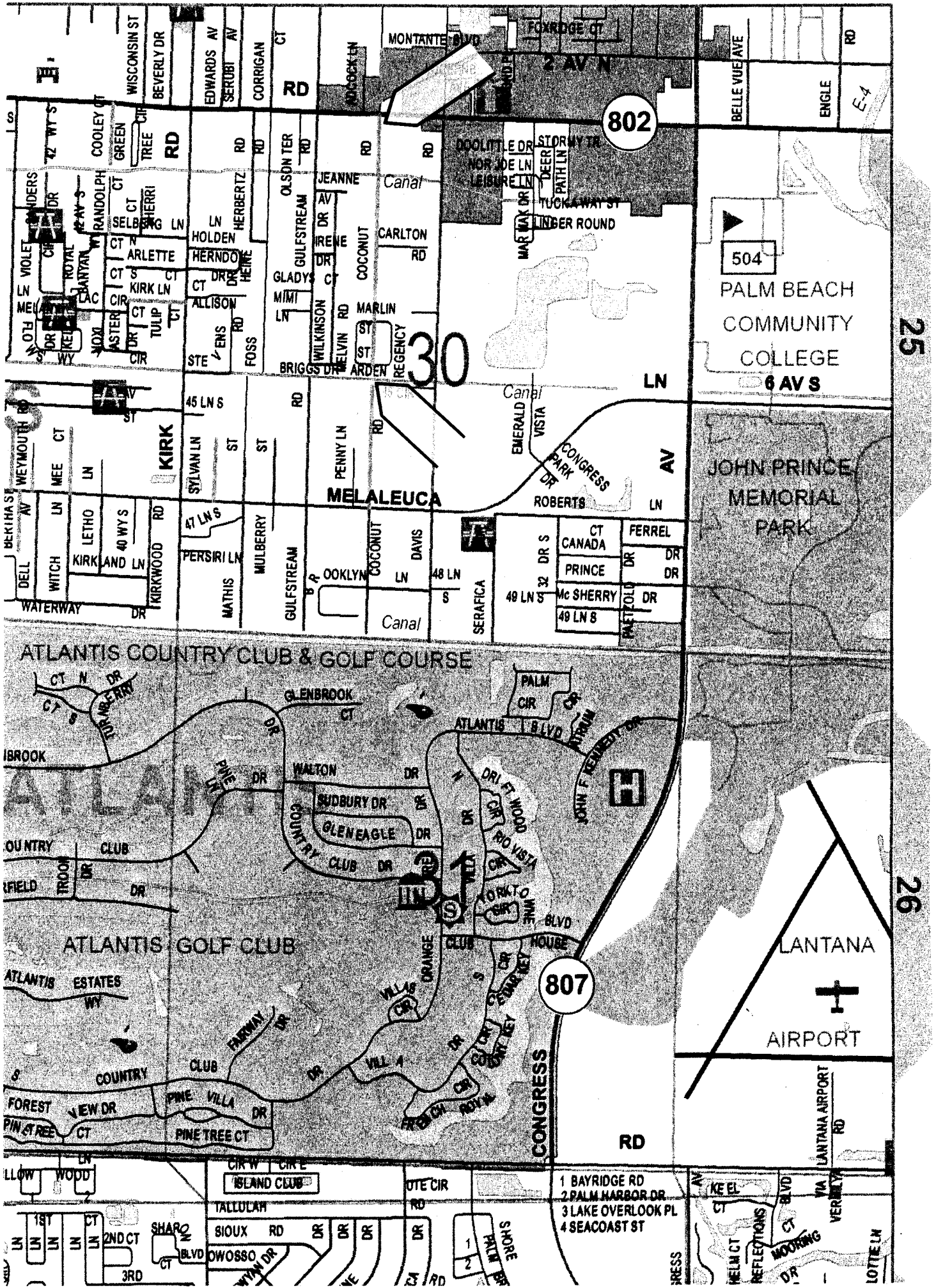

THIS TASK TO ANNUAL AGREEMENT, made and entered into _____, 2008 by and between Palm Beach County, hereinafter called the **COUNTY**, and **Civil Design, Inc.** a Florida Corporation with an address of 120 S. Olive Avenue, Suite 403, West Palm Beach, FL 33401, Corporate Tax I.D. #56-2355181, hereinafter called the **CONSULTANT**.

WITNESSETH

WHEREAS, the **COUNTY** and the **CONSULTANT** entered into an Annual Agreement on **April 10, 2007 (R-2007-0462)/Renewal dated March 11, 2008 (R-2008-0310)**, whereby the **CONSULTANT** was retained to furnish certain professional services required for MSTU Districts "A" through "E" on an annual basis. It is now necessary to acquire engineering, surveying, and permitting services for the **Coconut Road Paving and Drainage Improvement Project**, from its north terminus at Lake Worth Road to its south terminus at the LWDD L-13 Canal (approximately 2,685 linear feet), MSTU District 'C', Palm Beach County, Florida (hereinafter called the **PROJECT**); and

WHEREAS, the **COUNTY** now desires the **CONSULTANT** to perform engineering services for the **PROJECT**; and

RE: COCONUT ROAD PAVING AND DRAINAGE PROJECT, M.S.T.U. DISTRICT "C"

WHEREAS, the following fees have been negotiated and found to be reasonable and just compensation for the professional services to be performed by the **CONSULTANT**: **Basic Services**: a lump sum fee of \$42,951.39 for engineering and permit services; **Additional Services**: a lump sum fee of \$21,492.00 for surveying services to be performed by Keshavarz & Associates, Inc., and; **Reimbursable Expenses**: a lump sum fee of \$1,100.00 for permit application and governmental fees, **totaling \$65,543.39**, as outlined in the proposal package dated August 5, 2008, attached hereto as a part of Exhibit "A".

NOW, THEREFORE, THIS INDENTURE WITNESSETH: That for and in consideration of the mutual benefits to flow from each to the other, the parties hereto agree as follows:

1. The **CONSULTANT** agrees to provide professional services as described in Exhibit "A" of the Agreement known as "**SCOPE OF WORK**".
2. The **CONSULTANT** agrees to "**CERTIFICATION STATEMENTS**" as described in Exhibit "B" of the Agreement.
3. The **CONSULTANT** agrees to **SMALL BUSINESS/MINORITY/WOMEN BUSINESS ENTERPRISE (S/M/WBE) PARTICIPATION** as described in Exhibit "C" of the Agreement.
4. The **LETTER(S) OF INTENT** to perform as a SBE/MBE/WBE and/or sub-consultant as described in Exhibit "D" of the Agreement.
5. The **CONFLICT OF INTEREST DISCLOSURE FORM** as described in Exhibit "E" of the Agreement.
6. The **COUNTY** agrees to pay the **CONSULTANT** a fee of Sixty Five Thousand Five Hundred Forty Three and 39/100 Dollars.
7. The **CONSULTANT** agrees to indemnify, defend and hold harmless the **COUNTY** against all claims that may arise as a result of negligence, wrongdoing, misconduct or want of care by the **CONSULTANT**.

Except as hereby amended, changed or modified, all other terms and conditions of the original Agreement dated April 10, 2007 (R-2007-0462)/Renewal dated March 11, 2008 (R-2008-0310), and;

Supplements and Amendments thereto, shall remain in full force and effect.

Pursuant to our discussions, please find below a task list and lump sum fee proposal for the subject work to be performed under our annual contract for MSTU engineering services with Palm Beach County (PBC).

Project Description:

Project consists of the surveying, design and permitting of approximately 2,685 linear feet of roadway and drainage improvements along Coconut Road from its north terminus at Lake Worth Road to its south terminus at the LWDD L-13 Canal.

Basis of Scope & Scope of Services (by Task and Activity):

Task 1 includes field survey of the project by our subconsultant Keshavarz & Associates, Inc. Work includes the following:

1. Establish the base line control and identify stationing.
2. Stations will be set at 100 foot intervals.
3. Provide two cross sections of the L-12 canal (one at east R/W line and one at west R/W line) and of the L-13 canal at the southerly extension of the east and west R/W line.
4. The survey will contain vertical control pursuant to 3rd order level circuit based on Palm Beach County's Vertical Control Network.
5. Cross sections will be obtained at each property line, but not more than 100 foot intervals, and will include up to 20 feet on either side of the right-of-way. Twenty-seven total cross sections are assumed.
6. Topography will be obtained and project tie-in will be performed.
7. Reference control points will be set for horizontal and vertical control for construction plans.

Task 2 includes engineering design services required to produce construction plans ready for permitting by those Authorities Having Jurisdiction (AHJ's) over the project. This task includes the following:

1. Consultant will coordinate the work of its subconsultant and attend meetings with Palm Beach County staff to review plans at each submittal stage. Up to three meetings are anticipated in this activity.
2. Consultant will make one site visit to verify existing conditions.
3. Consultant will coordinate utilities will add franchise utility information to drawings as provided by the respective utility so that conflicts can be coordinated and minimized.

4. Consultant will prepare a cover sheet for the project plan set that will include project location map, governing standard references, index, legend, project length and engineer's certification. One sheet is anticipated for this activity.
5. Typical section/detail sheets will be prepared to include a typical road section for the road improvements and applicable Palm Beach County details. Two sheets are anticipated for this activity.
6. A specification and quantity sheet, including summary of quantities, will be prepared. Activity includes preparing a plan take-off of quantities to complete the summary of pay items table. One sheet is anticipated for this activity.
7. Plan and profiles sheets will be prepared identifying the proposed improvements. Plans will include up to 600 linear feet each (6 stations) and are expected to be prepared at 1"=20' for 24"x36" plans sheets. Five sheets are anticipated for this activity.
8. A construction control sheet will be prepared depicting the survey reference data by station, offset, description and elevation. Two sheets are anticipated for this activity.
9. An engineer's opinion of probable construction costs will be prepared utilizing the summary of quantities obtained from the design plans and recent bid unit price information.

Task 3 includes permitting services required to produce construction plans ready for construction by those Authorities Having Jurisdiction (AHJ's) over the project. Consultant will respond to usual and customary requests for additional information from these AHJ's. This task includes the following:

1. Plans and calculations approval is anticipated to be approved under the South Florida Water Management District "No-Notice" General Environmental Resource permit criteria. There is a \$100 permit fee for this permit application.
2. The site is within the limits of the Lake Worth Drainage District and as such, a permit application will be submitted. There is a \$1,000 fee for this permit application.

Project Schedule:

It is anticipated that the survey (Task 1) can be completed within 45 days of the Notice to Proceed (NTP) and that plan preparation (Task 2) can be completed within 90 days thereafter (135 days from NTP). Permitting (Task 3) is anticipated to take 90 days after completion of Task 2, however, the approval of permit applications is outside the Consultant's control.

1. Survey work will be subcontracted to Keshavarz & Associates, Inc.
2. Plan submittals will be prepared and submitted at the 35%, 65% and 100% stages for PBC review.
3. Design is based on providing water quality in roadside swales with raised inlets and driveways.
4. There are no offsite improvements (i.e. upsizing existing facilities) anticipated in this Agreement.
5. Details sufficient to construct the project will be referenced or provided on the plans. Therefore, preparation of technical specifications is not included in this scope of services.
6. Construction observation services are not included in this scope of services.
7. Project will be billed as completed through the billing period at each deliverable stage. The attached lump sum fee proposal is provided for information and the rates are based on our approved PBC MSTU annual agreement.
8. In the event that SFWMD determined that project does not comply with the No-Notice permit criteria, additional permitting fees will be required to apply for a different permit.




