# SEVENTH AMENDMENT TO TERMINAL BUILDING LEASE AGREEMENT BETWEEN PALM BEACH COUNTY AND THE GENERAL SERVICES ADMINISTRATION

THIS SEVENTH AMENDMENT TO TERMINAL BUILDING LEASE AGREEMENT (this "Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2008, by and between Palm Beach County, a political subdivision of the State of Florida (the "County), and the General Services Administration, an Executive Agency of the United States of America ("Lessee").

#### WITNESSETH:

WHEREAS, County, by and through its Department of Airports (the "Department") owns and operates the Palm Beach International Airport, located in Palm Beach County, Florida (the "Airport); and

WHEREAS, pursuant to that certain Terminal Building Lease Agreement between County and Lessee dated March 11, 2003 (R2003-0355), as amended (the "Lease"), Lessee leases 4,776 square feet of space, consisting of 910 square feet of Type 2 Space at a rate of \$70.68 per square foot, 3,866 square feet of Type 4 Space at a rate of \$54.97 per square foot and an ATO Office Common Area Charge of \$24,608.98 for certain common areas within the terminal building. The total annual rental is \$301,441.80; and

WHEREAS, LESSEE acknowledges the rental rates set forth above are adjusted annually; and

WHEREAS, the parties hereto desire to amend the Lease in accordance with the terms and conditions set forth herein.

- NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained, and for such other good and valuable consideration, the receipt of which the parties hereby expressly acknowledge, the parties hereto covenant and agree to the following terms and conditions:
- 1. The foregoing recitals are true and correct and are hereby incorporated herein by reference. Terms not defined herein shall have the meanings ascribed to them in the Lease.
- 2. Article 3.01 of the Lease is hereby deleted in its entirety and replaced with the following:
- 3.01 <u>Term.</u> This Lease shall become effective on November 1, 2002 and shall terminate on October 31, 2011 (the "Term"), unless sooner terminated as provided for herein.
  - 3. Except as specifically modified herein, all of the terms and conditions of the Leases shall remain unmodified and in full force and effect and are hereby ratified and confirmed by the parties hereto.
  - 4. This Amendment shall become effective when signed by the parties hereto and approved by the Palm Beach Board of County Commissioners.
