### I. EXECUTIVE BRIEF

**Motion and Title:** Staff recommends motion to approve: a First Amendment to the agreement (2006-0074) with Barton Security Services, LLC d/b/a Allied Barton Security Services allowing for interoperable communications through the Countywide and EMS common groups of the County's 800MHz Radio System.

**Summary:** The Agreement which provides the terms and conditions under which Barton can program into its radios and utilize the countywide and EMS common talk groups for certain types of inter-agency communications will expire on January 9, 2009. The agreement provides for one (1) – three (3) year renewal but renewals require approval by both parties. Barton has approved a renewal to extend the term of the agreement until January 10, 2012. The renewal now requires Board approval. The Agreement may be terminated by either party, with or without cause, with a minimum of eight (8) months notice. (ESS) <u>Countywide</u> (JM)

**Background and Justification:** The Agreement which provides the terms and conditions under which Barton program into its radios and utilize the countywide and EMS common talk groups for certain inter-agency communications will expire on January 9, 2009. Barton will only be able to access the common talk groups for specified types of communications and will conduct routing operational communications on its own radio system. As such there is no capacity impact to the County and hence no charges associated with this Amendment.
