I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Payment in the amount of \$18,895 to Stonegate Homeowner's Association (HOA) for damages to irrigation, lighting and landscaping systems during the construction of improvements on Greenview Shores Boulevard, from South Shore Boulevard to Wellington Trace (Project).

SUMMARY: Approval of this action will allow payment to the HOA for damages incurred to their irrigation, lighting and landscaping during the construction of the Project.

District 6 (PK)

Background and Justification: In order to perform the construction of improvements on Greenview Shores Boulevard from South Shore Boulevard to Wellington Trace, Palm Beach County had to acquire a Temporary Construction Easement (TCE) on property owned by the HOA. In lieu of the County acquiring the TCE through possible eminent domain proceedings with estimated costs exceeding \$25,000, the HOA agreed to execute a Restoration Agreement at no cost to the County, provided the County pay for any damages to HOA owned improvements, caused by the Project. Damages were incurred to certain irrigation, lighting and landscaping during the installation of a drainage pipe and pavement work required for the Project. The HOA has submitted invoices and requested payment for the repair and/or replacement of those damaged improvements. Staff has reviewed the invoices and find them acceptable.



PERMISSION IS HEREBY GRANTED, this $18^{\frac{74}{2}}$ day of APRiL, 2005, to Palm Beach County (hereinafter, County), and County's employees, agents, contractors, sub-contractors and/or assigns by STONEGATE HOMEOWNERS ASSOCIATION, INC. (hereinafter, Owner) to enter onto and restore property described above.

The construction of this roadway section will use the entire right-of-way width of 120 feet and,

In order that abutting lands of the Owner may conform, tie in and harmonize with the construction, it will be necessary to slope and grade a portion of abutting lands of the Owner.

NOW, THEREFORE, WITNESSETH, the Owner or the Owner's undersigned agent hereby grants unto the County and the County's employees, agents, contractors, sub-contractors and/or assigns, the irrevocable permission and right to enter upon and restore the abutting land of the Owner.

The irrevocable permission granted above shall not extend beyond a distance of 60 feet from the right-of-way line as required for the purposes described herein.

As consideration for the above permission, it is understood and agreed by the Owner that the County and the County's employees, agents, contractors, sub-contractors and/or assigns, shall slope and grade where necessary to return the property to as near as practicable to the same condition as before.

IT IS FURTHER UNDERSTOOD AND AGREED by the Owner that the right to enter and restore granted herein is irrevocable and shall cease upon acceptance of the construction by the County.
