#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: the Fiscal Year 2008/2009 Pathway Program.

**SUMMARY:** A list of the proposed projects in the Annual Pathway Program for the Fiscal Year 2008/2009 has been compiled in response to requests from the Palm Beach County School Board, Palm Beach County Sheriff's Office, members of the Board of County Commissioners, and residents of Palm Beach County. The proposed projects include nine new construction projects and eight major maintenance projects. The total program cost is \$1,500,000 and is divided into the following categories:

Major Maintenance	\$267,000
School Related	\$1,134,000
ADA and Minor Maintenance	\$53,000
Cost and Feasibility Studies	\$36,000
Fast Track Schools	\$10,000
Total	\$1,500,000

**Background and Justification:** The purpose of the Pathway Program is to provide a system of safe pedestrian pathways in Palm Beach County, with emphasis being given to providing pedestrian access to schools. All requests were reviewed by the Traffic Engineering Division. The proposed program was previously sent to each Commissioner.






