RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, CHANGING THE STREET NAME OF OKLAWAHA AVENUE TO RED TRAIL, LOCATED IN SECTION 29, TOWNSHIP 43, RANGE 43.

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, is authorized under Section 336.05, Florida Statutes, to name and rename streets and roads lying outside the boundaries of any incorporated municipality; and

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, has, by Resolution No. R-74-183, as amended and supplemented by Resolution No. R-91-1145, adopted a system of street naming and numbering for Palm Beach County; and

WHEREAS, the Administration Division of the Palm Beach County Planning, Zoning and Building Department has reviewed the situation and finds that the proposed name, Red Trail, does not duplicate any other street name in Palm Beach County; and

WHEREAS, the road which will be renamed has fifteen (15) industrial lots that will be effected by the change. All property owners have signed a petition agreeing to the street name change; and

WHEREAS, Robert E. Deziel has paid all application fees to process the vanity street name change; and

WHEREAS, the Planning, Zoning and Building Department has reviewed the proposed street name changes and finds this request consistent with adopted County policy and procedures for vanity street name changes and that the change meets all specified conditions.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. Oklawaha Avenue, located in Sections 29, Township 43, and Range 43 is

hereby changed and the street shall be known as Red Trail. This road is delineated on the accompanying map and the resolution shall be recorded in the Public Records of Palm Beach County.

- 2. All appropriate agencies shall be notified by the Palm Beach County Planning, Zoning and Building Department of such official change.
- 3. The Clerk of the Court shall indicate the street name changes on the affected plat and/or plats.


