## I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Recreation Assistance Program allocation to the Parks and Recreation Department in an amount not-to-exceed \$3,853 for the Veteran's Park Veterans' Day event.

**Summary:** This allocation provides \$3,853 to fund the Veterans' Day event held on November 12, 2008, at Veteran's Park in Boca Raton. This event was held in cooperation with the Veteran's Coalition of South Florida for an expected audience of 500 people. Funding is from the Recreation Assistance Program (RAP) District 5 Funds. <u>District 5</u> (DW)

**Background and Justification:** The annual Veterans' Day event has been funded by the District 5 Commissioner for the past six years. Eligible expenses consist of tents, chairs, food items, beverages, food carts, cafeteria serving units including steam table, and emergency medical services. Procurement of these items was handled by the Parks and Recreation Department's Special Events section.
