I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a budget amendment of \$8,500 in the General Fund to recognize the collection of fees for Training and Organizational Development services.

Summary: Revenue generating County departments and entities whose employees attend Training and Organizational Development programs delivered by outside consultants are charged back the cost-per-person (cost of consultant's fees divided by the number of attendees) for each employee. This revenue is not currently included in the Department budget and is needed to partially cover vendor payments and costs incurred in providing training and development services. <u>Countywide</u> (EC)

Background and Policy Issues: Training and Organizational Development is a section of the Human Resources Department responsible for delivering on-going training and development services to county employees and departments. Due to this section's significant budget cuts, the loss of a position, and the launching of a new leadership development program in response to concerns about succession planning, these charge back fees are needed to meet the responsibilities of the section.
