Based upon historical usage (\$306,756) and a 5.4% CPI increase (\$17,176) as set forth in the existing contract, \$323,932 is needed to meet the County's requirements through the expiration of this twelve (12) month renewal term contract. This term contract has one (1) twelve (12) month renewal option remaining. No certified SBE vendor submitted a bid on this project.

The County has encumbered \$496,285 (\$16,010/month) during the current thirty-one (31) month term contract. Based upon historical usage, \$576,330 is needed to meet the County's requirements for this new thirty-six (36) month term contract. This term contract has no renewal options remaining. This purchase is off the US Communities contract #05091MRO due to lack of SBE competition for this commodity.

At the October 7, 2008 meeting, the BCC approved the selection of Minnesota Life Insurance Company as the provider for fully insured group term life and accidental death and dismemberment (AD&D), with approval of the negotiated contract to be brought at a later date. This new three (3) year term contract for Term Life and AD&D Insurance includes guaranteed rates at an estimated cost of \$1,350,000 per year, with two (2) twelve (12) month renewal options at a defined rate formula. Of the annual estimated cost, the BCC's cost is \$381,000 and the employee's cost is \$969,000. Under this new term contract the BCC's rate will decrease from .28¢ per \$1,000 of benefit to .245¢, and the employee's voluntary rates will decrease from .46¢ per \$1,000 of benefit to .41¢. This contract was established by a competitive RFP process that allowed up to ten (10) points for SBE participation. No certified SBE participation was offered by the selected awardee.

(a) This term contract is to purchase and install an automatic vehicle locating system with automatic passenger county devices, with three (3) years standard warranty and maintenance and four (4) years of extended maintenance upon completion of system acceptance testing. \$3,742,039 is required to purchase and install the system plus three (3) years standard warranty and maintenance, and \$768,315 is required for four (4) years of extended maintenance.

(b) This term contract is for the software licensing agreement required to operate the automatic vehicle locating system and automatic passenger counting devices.

Because of Federal funding, this project must adhere to the Federal DBE program rather than the County's SBE program. This contract was established by competitive RFP process.
