I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Payment in the amount of \$688.96 to the Leon County Board of County Commissioners for Palm Beach County's pro-rata share of the Nabors Giblin & Nickerson invoice for professional services rendered through September 30, 2008, in the Criminal Conflict and Civil Regional Counsel litigation styled *Leon County, et al. v. Jeffrey Lewis, et al.,* Second Judicial Circuit Civil Case No. 2008-CA-2475.

Summary: Leon County retained Nabors Giblin & Nickerson to challenge the state law that requires the counties to fund the Office of Criminal Conflict and Civil Regional Counsel. In response to the request for other counties to participate in the litigation, the County Attorney recommended that Palm Beach County join and expend up to \$6,000. Receiving no objection, Palm Beach County was named along with 25 other counties as a plaintiff in the subject action. This item requests approval of the Nabors Giblin & Nickerson invoice attached, which is the first invoice for professional services rendered. Subsequent invoices will be submitted for approval as they are received. <u>Countywide</u> (DMN)

Background and Justification: During the 2007 legislative session, the State Legislature created the Office of Criminal Conflict and Civil Regional Counsel. This office was created to provide "adequate representation to persons entitled to court-appointed counsel under the Federal or State Constitution or as authorized by general law" according to Florida State Statute 27.511; i.e., to provide legal services to criminal defendants whom the Public Defender's Office could not represent due to conflicts of interest, and to supervise private court-appointed attorneys in child dependency cases and other civil actions. The result of this legislation is that counties are burdened with the funding of the Office of Criminal Conflict and Civil Regional Counsel.

Two complaints in Leon County Circuit Court were filed in July 2008 challenging the constitutionality of the new state statute. The first complaint was filed by 25 counties, including Palm Beach County, and the Florida Association of Counties (FAC) against the four Regional Conflict Counsels, as well as the Speaker of the House and the President of the Senate. The second suit was filed by Volusia County alone against the State of Florida and other entities. Both cases have similar issues and were consolidated before the same judge. The Defendants filed a Motion to Dismiss on numerous grounds, which was denied with regard to Palm Beach County, et.al. on October 13, 2008. Any additional dispositive motions must be filed and responded to by December 3, 2008, with a hearing on those motions set for December 12, 2008. No trial date has been set.
