I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 2 to the Contract with Stephen L. Boruff, AIA, Architects & Planners, Inc. (R2006-0073) for architectural services for Fire-Rescue projects on a continuing contract basis.

Summary: Stephen L. Boruff, AIA, Architects & Planners, Inc., is under contract to provide professional architectural services for Fire-Rescue projects generally with a construction value up to \$3,500,000. The contract provided for an initial two (2) year term with three (3) - one (1) year renewal options. Amendment No. 2 would provide for services during the second renewal period. Stephen L. Boruff, AIA, Architects & Planners, Inc. has an SBE participation goal of 15%. During the first three years of the Contract, Stephen L. Boruff, AIA, Architects & Planners, Inc. has achieved 88.5% participation. (Capital Improvements Division) Countywide (JM)

Background and Justification: In accordance with Board adopted procedures pursuant to Florida Statute 287.055 (Consultants Competitive Negotiation Act, CCNA), Stephen L. Boruff, AIA, Architects & Planners, Inc. was selected to perform professional architectural consulting services on a continuing contract basis. Work is authorized through individual task agreements when required during the term of this contract. The contract term is for two (2) years and the original Board action allowed for three (3) additional one (1) year renewals. Amendment No. 2 would provide services during the second renewal period and would be the fourth year of the contract. This Amendment will maintain the continuous professional services required by Palm Beach County. During the first year of the Contract, Stephen L. Boruff's office was awarded \$826,470 in Consultant Service Authorizations.
