### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Budget Transfer of \$50,000 in the Park Improvement Fund from Reserves to Sansbury Way Park.

**Summary:** This budget transfer will provide additional funding for professional planning services necessary to process a Development Order Amendment application and other associated costs for District Park "K" also known as Sansbury Way Park. Funding is from the Park Improvement Fund Reserve. District <u>6</u> (DW)

**Background and Justification:** Sansbury Way Park is an undeveloped park property located on Jog Road and Belvedere Road in West Palm Beach. Professional planning services are needed to prepare, process and expedite a Development Order Amendment application. Estimated costs include a consultant contract, filing fee, related mailing and postage fees, as well as other application and site expenses.
