I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

- A) A Budget Transfer of \$50,000 in the Transportation Improvement Fund from Reserves for District 1 to Indian Creek Parkway and Egret Landing Boulevard Signal; and
- **B)** A Budget Amendment of \$52,000 in the Transportation Improvement Fund to recognize contributions from the Town of Jupiter of \$26,000 and Egret Landing Home Owners Association of \$26,000 for the Indian Creek Parkway and Egret Landing Boulevard Signal.

SUMMARY: Approval of these actions will fund the installation of a mast arm traffic signal. Part of the funding will be a budget transfer from District 1. The remainder of the funding will come from the Town of Jupiter, the Egret Landing Home Owners Association and the Traffic Division.

District 1 (MRE)

Background and Justification: A span wire traffic signal was authorized for the intersection of Indian Creek Parkway and Egret Landing Boulevard. The installation of the span wire signal was partially completed when residents of Egret Landing Home Owners Association expressed opposition to the span wire design. The reason for their opposition included: mast arm traffic signals are more resistant to storm damage than span wire traffic signals, and the span wire pole was placed in front of the community's entrance sign.

The incremental cost of the mast arm traffic signal versus the span wire traffic signal is \$102,000. The mast arm traffic signal design would place the pole behind the community's entrance sign. The District 1 Commissioner has authorized \$50,000 toward the incremental cost. The Town of Jupiter and Egret Landing Home Owners Association have each agreed to pay \$26,000 toward the incremental cost. They have signed a Memorandum of Understanding to provide the funds.



EGRET LANDING TRAFFIC SIGNAL MEMORANDUM OF UNDERSTANDING Page 1

BACKGROUIND

The Palm Beach County Traffic Division has designed a span wire traffic signal at the intersection of Indian Creek Parkway and Egret Landing Boulevard. The installation of this span wire signal has been partially completed. The Town of Jupiter and the Egret Landing HOA wish to have a mast arm signal installed at this location. Based on a preliminary design investigation, it appears to be possible to install a mast arm traffic signal at this location. The design would include a double mast arm on the north side of the intersection and a single mast arm on the southeast corner. The mast arm pole on the southeast corner would be located behind the Egret Landing entrance wall.

COST INCREASE FOR MAST ARM TRAFFIC SIGNAL

The mast arm traffic signal design at this location will require the installation of mast arm poles and foundations, additional conduit, additional cable, additional pull boxes and illuminated street name signs, that are not requires for the span wire traffic signal design. It will also require the removal of the span wire poles that have been installed. The traffic signal controller and control box assembly, traffic signal heads, pedestrian signal heads, vehicle detection loops, wiring, conduit, and pull boxes that are needed for the span wire traffic signal design were not included in the estimated increased cost of the mast arm traffic signal. The estimated increase cost of the mast arm traffic signal is \$102,000.

FUNDING

The Palm Beach County Traffic Division was funding the installation costs of the span wire traffic signal from the Division's operating funds. The Traffic Division will apply the funds that were to be used for the span wire traffic signal toward the mast arm traffic signal.

The increased cost of the mast arm traffic signal will be funded as stated below:

- Commission District 1 Gas Tax Funds	\$50,000
 Town of Jupiter Egret Landing Home Owners Association 	\$26,000 \$26,000
- Total	\$102,000

EASEMENT

In order to address the aesthetic concern of the Egret Landing HOA, the mast arm pole on the southeast corner will be placed behind the entrance wall. An easement from the Egret Landing HOA to Palm Beach County will be needed to construct the mast arm behind the wall. The Egret Landing HOA will provide the easement in accordance with the dimension and location to be determined by the mast arm traffic signal plan. The easement will be cleared of all obstruction, including palm trees, irrigation and lighting.

The Palm Beach County Traffic Division will prepare the legal description for the easement.

TIMING

The Palm Beach County Traffic Division will begin design of the mast arm traffic signal upon the execution of this Memorandum of Understanding by all parties.

The Palm Beach County Traffic Division will issue a work order for the construction of the mast arm traffic signal upon completion of the following:

- Completion of the mast arm traffic signal design
- A budget transfer of \$50,000 from Commission District 1 Gas Tax Funds
- Payment of \$26,000 from the Town of Jupiter
- Payment of \$26,000 from The Egret Landing HOA
- Recording the easement and removal of obstruction from the easement
