I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a First Amendment to the interlocal agreement (R2003-1698) with the Town of Manalapan (Town) allowing for interoperable communications through the Countywide common groups of the County's 800MHz Radio System.

Summary: The Agreement which provides the terms and conditions under which the Town can directly access the County's 800 MHz Radio System expired on October 21, 2008. The agreement provides for three (3) – five (5) year renewals but renewals require approval by both parties. The Town has approved a renewal to extend the term of the agreement until October 21, 2013 as originally contemplated. The renewal now requires Board approval. The terms of the agreement are standard and have been offered to all municipalities and local branches of State/Federal agencies. The Agreement may be terminated by either party, with or without cause. (ESS) Countywide (JM)

FIRST AMENDMENT TO INTERLOCAL AGREEMENT

THIS FIRST AMENDMENT to Agreement R2003-1698 is made as of _____, by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as the County, and the Town of Manalapan, Florida, a municipal corporation, hereinafter referred to as the Town.

In consideration of the mutual promises contained herein, the County and Town agree as follows:

1. The term of Agreement R2003-1698 expires on October 21, 2008 and shall be retroactively extended to October 21, 2013.
2. All other terms of Agreement R2003-1698 remain unmodified and in full force and effect.
