I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Tenth Amendment to Contract with CGI-AMS (formerly named American Management Systems, Inc.) (R2002-1782), to extend the ending date from December 31, 2008 to December 30, 2009, at no additional cost to the County.

Summary: The Tenth Amendment is an extension to allow additional time for completion of the deliverables specified in the original contract, including Vendor Self Service and modifications No. 9 and No. 11. Countywide (PK)

Background and Justification: On October 2, 2002, the Board approved the migration of the County's Financial System from the mainframe-based LGFS version to the web-based Advantage System. The implementation and installation of the Vendor Self Service module is still pending due to a mutual decision by the County and the vendor. The Tenth Amendment extends the contract to provide time required for work on the Vendor Self Service module now scheduled for completion in 2009.

The Tenth Amendment also provides additional time for modifications #9 & #11. Modification #9 provides the ability to view payments to vendor by calendar year including detail. Modification #11 provides the ability to systematically handle mass reorganization or changes in Fund types in an efficient manner.
