I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: time extensions to the standard renewal agreements with the following providers: Dr. Byron Reid d/b/a Byron Reid & Associates V.M.D.P.A. for the provision of large animal services, Dr. Michael Geraghty, D.V.M. d/b/a Pet Emergency of Palm Beach County and Dr. Xavier Garcia, D.V.M. d/b/a El Cid Animal Clinic, for the provision of relief veterinary services and emergency on-call after-hour veterinary services upon request by Animal Care and Control for an additional one year period from October 1, 2008, to September 30, 2009 at an annual cost not to exceed \$10,000.

Summary: On May 6, 1997, the Board adopted a resolution authorizing the County Administrator, or his designee, to execute standard contracts with various Florida licensed veterinarians to provide needed part-time, relief and emergency "on-call" professional medical services for shelter animals. <u>Countywide</u> (SF)

The renewals have been reviewed by the Department of Public Safety and find them to be in compliance with the approved contracts.
