I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: **A) Adopt** Resolution of the Board of County Commissioners of Palm Beach County, Florida, changing the street name of Oriole Country Road to Judge Winikoff Road, located in Sections 14, 23, 25 & 26, Township 47, Range 41, West Palm Beach; and **B) Approve** a Budget Transfer from the Transportation Improvement Fund Reserves for District 5 Improvements which will be utilized to pay the \$1,400.00 application fee for street name changes.

Summary: The Board of Directors of the West Boca Community Council has asked the Palm Beach County Board of County Commissioners to rename Oriole Country Road to Judge Winikoff Road to honor Circuit Court Judge Winikoff who passed away on June 17, 2008. Approval of the Budget Transfer will provide funds for the fees associated with the name change process.




Upon receiving a copy of the approved resolution, PZ&B Staff will implement the name change by notifying appropriate parties and agencies. (District 5) RB

Background and Policy Issues: Oriole Country Road is located in the unincorporated area of Boca Raton beginning just north of Glades Road to its end at South State Road 7. There are eight (8) property owners who will be affected by this change. All eight (8) property owners have been notified by mail of this proposal. The District 5 Commissioner has agreed to provide the funds necessary to cover the fees associated with the Judge Winikoff name change.

This request is consistent with adopted County policies and procedures for vanity street name changes set forth in Resolutions R-74-183 and R-91-1145. No policy issues are associated with this agenda item.

RESOLUTION NO. R-

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, CHANGING THE STREET NAME OF ORIOLE COUNTRY ROAD TO JUDGE WINIKOFF ROAD, LOCATED IN SECTIONS 14, 23, 25 & 26, TOWNSHIP 47, RANGE 41.

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, is authorized under Section 336.05, Florida Statutes, to name and rename streets and roads lying outside the boundaries of any incorporated municipality; and

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, has, by Resolution No. R-74-183, as amended and supplemented by Resolution No. R-91-1145, adopted a system of street naming and numbering for Palm Beach County; and

WHEREAS, the Board of County Commission directed staff to change Oriole Country Road to Judge Winikoff Road in honor of the work he did for the community; and

WHEREAS, the Administration Division of the Palm Beach County Planning, Zoning and Building Department has reviewed the situation and finds that the proposed name, Judge Winikoff Road, does not duplicate any other street name in Palm Beach County; and

WHEREAS, the road which will be renamed has eight (8) parcels that will be effected by the change, of which all property owners will be notified of the change; and

WHEREAS, the Planning, Zoning and Building Department has reviewed the proposed street name change and finds this request consistent with adopted County policy and procedures for street name changes and that the change meets all specified conditions.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. Oriole Country Road, located in the unincorporated area of Boca Raton beginning just north of Glades Road to its end at South State Road 7 is hereby changed and the street shall be known as Judge Winikoff Road. This road is

delineated on the accompanying map and the resolution shall be recorded in the Public Records of Palm Beach County.

2. All appropriate agencies shall be notified by the Palm Beach County Planning, Zoning and Building Department of such official change.

3. The Clerk & Comptroller shall indicate the street name changes on the affected plat and/or plats.

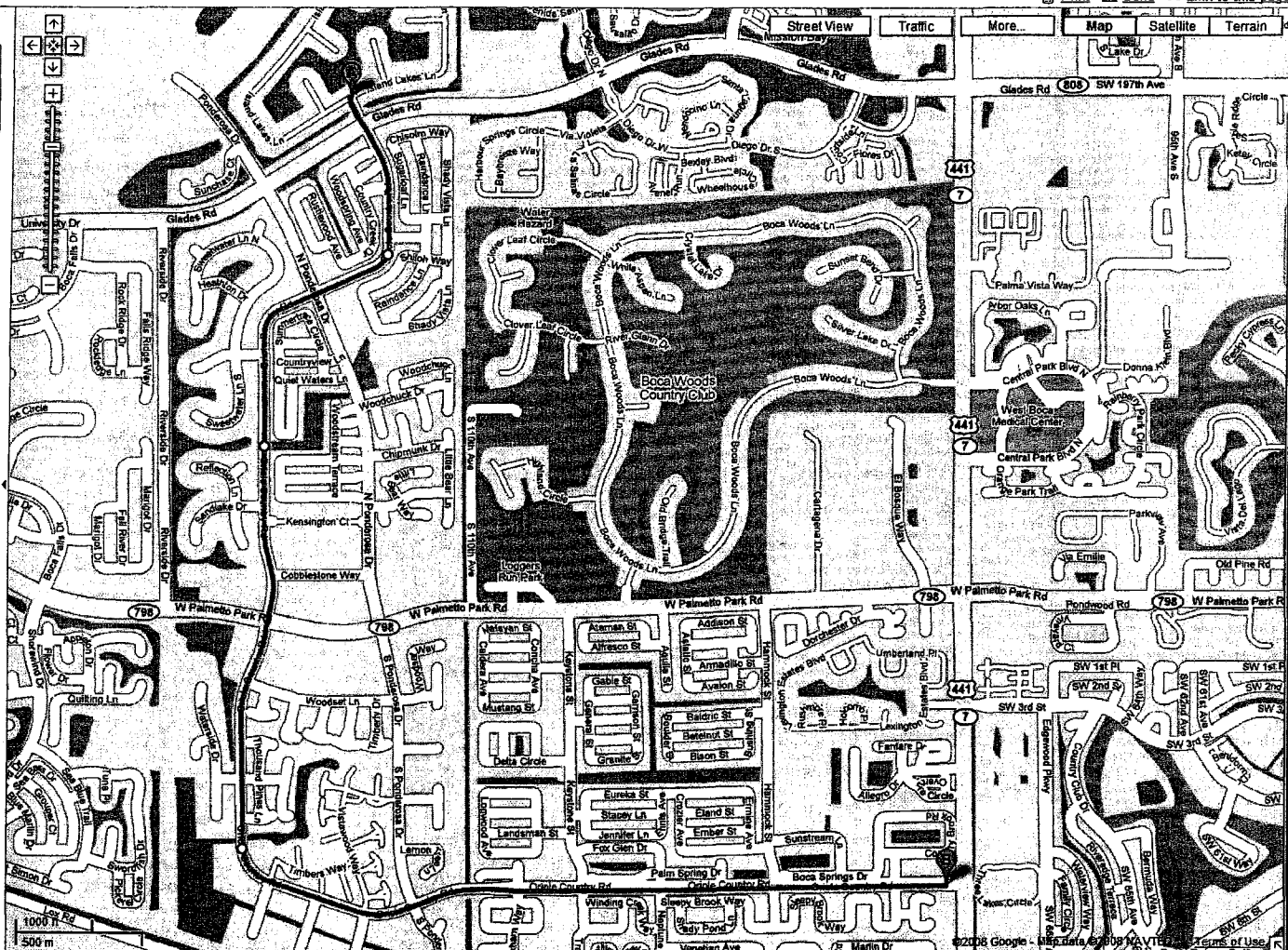

In accordance with the standards and requirements for naming streets as set forth in Resolution No. 74-183 and amended in Resolution No. 91-1145, street name changes shall be permitted in response to a Board of County Commissioners' directive.

The purpose of this letter is to announce the initiation of a name change for Oriole Country Road.
