I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a First Amendment to the Interlocal Agreement (R2005-0099) with the Health Care District (District) of Palm Beach County.

Summary: The Agreement which provides the terms and conditions under which the County provides comprehensive fleet and fuel management services to the District will expire on July 8, 2009. The agreement provides for one (1) - five (5) year renewal but renewals require approval by both parties. The District has approved a renewal to extend the term of the agreement through July 7, 2014. The renewal now requires Board approval. The County does not require any additional staffing and/or equipment to extend this Agreement, and as such, this Agreement will result in increased revenues to Fleet Management. (FD&O Admin) Countywide (JM)

Background and Justification: The Interlocal Agreement with the District provides the terms and conditions under which the County provides fleet management services will expire on July 8, 2009. The Agreement provides for one (1) - five (5) year renewal but renewals require approval by both parties. The District has approved a renewal to extend the term of the agreement until July 7, 2014. Since the County does not require additional staffing and/or equipment to extend this Agreement, there will be an increase in the revenues to Fleet Management as a result of this Agreement. The actual amount of revenue to be generated will depend on the level of use by the District.
