RESOLUTION NO. R-2009- \_\_\_\_\_

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA URGING THE FLORIDA LEGISLATURE TO PROVIDE AN ANNUAL DEDICATED FUNDING SOURCE FOR THE SOUTH FLORIDA REGIONAL TRANSPORTATION AUTHORITY THROUGH A NEW \$2 RENTAL CAR SURCHARGE.

WHEREAS, Section 343.58, Florida Statutes, currently requires Miami-Dade, Broward, and Palm Beach Counties to annually contribute \$4.2 million each to the South Florida Regional Transportation Authority (SFRTA); and

WHEREAS, even with these contributions, the SFRTA is currently suffering from budgetary shortfalls; and

WHEREAS, authorizing a new dedicated funding source for the SFRTA would relieve Miami-Dade, Broward, and Palm Beach Counties from the possibility of increased annual subsidies to the SFRTA; and

WHEREAS, the BCC has stated that future funding for SFRTA is contingent on identification and implementation of a dedicated funding source; and

WHEREAS, a new \$2 rental car surcharge is estimated to generate approximately \$50 million annually that could be used to help fund the SFRTA.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature to provide an annual dedicated funding source for the South Florida Regional Transportation Authority through a new \$2 rental car surcharge.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this Resolution to the Governor, Senate President, House Speaker, the Chair and Members of the Palm Beach County State Legislative Delegation, the Members of the Broward County Board of County Commissioners, the Members of the Miami-Dade Board of County Commissioners, and the Governing Board of the South Florida Regional Transportation Authority.

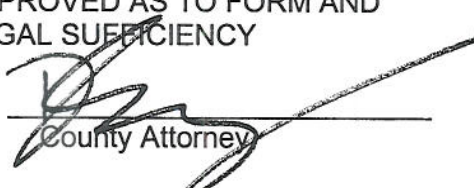
