I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 2 to Children's Case Management Organization, Inc. dba Families First (R2007-1939) for the period October 1, 2008, through September 30, 2009, to correct the unit of service definition.

Summary: Amendment 1 extended the contract through FY2009 and the unit pricing was based on ¼ hour of service as the billable unit of service. However, the definition of a unit of service was inadvertently not revised from the one hour originally stated in the contract. The unit will now be defined as fifteen (15) minute increments of service delivery that may include home visits, face to face contacts, school visits, collateral visits, workshops, or supervision to discuss case consultations and direction for the needs of the family served. The service description is not changing and they will continue to provide the same services as contracted for in November 2008. There is no change to the contract amount and no additional funding is being requested. This correction is retroactive to October 1, 2008 <u>Countywide</u> (TKF)

Background & Justification: The Families First contract needs to be adjusted to ensure proper billing of services provided to clients.

THIS AMENDMENT TWO TO THE FINANCIALLY ASSISTED AGENCIES CONTRACT(R2007-1939, November 6, 2007) made and entered into at West Palm Beach Florida, on this _____ day of _____, 2009 by and between PALM BEACH COUNTY, hereinafter referred to as "COUNTY" and <u>Children's Case Management Organization</u>, Inc. dba Families <u>First</u> hereinafter referred to as the AGENCY, a not-for-profit corporation, entitled to do business in the State of Florida, whose address is 3333 Forest Hill Blvd. 2nd Floor, West Palm Beach, Fl. 33406.

WITNESETH:

WHEREAS, the contract was extended and modified by amendment one per (R2008-2125) November 18th, 2008 and;

WHEREAS, the need exists to correct the definition of a unit of service set forth in the Exhibit "B1" Service Program to Be Provided in FY 2009.

NOW THEREFORE, the above named parties hereby mutually agree that the definition of a unit of service in Exhibit B1 is corrected from "a unit of service is defined as one (1) hour of service and may include one home visit, one face to face, one telephone call, one school visit, one collateral visit, or one workshop" to now read "A unit of service is defined as fifteen (15) minute increments of service delivery that may include home visits, face to face contacts, school visits, collateral visits, workshops, or supervision to discuss case consultations and direction for the needs of the family served."

OTHER PROVISIONS

The above correction is retroactively applicable to all services provided on and after October 1, 2008.

All provisions in the Contract or exhibits to the Contract in conflict with this Second Amendment to the Contract shall be and are hereby changed to conform to this amendment.

All provisions not in conflict with this Amendment are still in effect and are to be performed at the same level as specified in the Contract.
