The County has encumbered \$8,255,957 (\$446,267/month) during the previous eighteen and a half (18.5) months of the current thirty-six (36) month term contract. Environmental Resources Management has requested an increase of \$7,430,000 over the previously authorized amount of \$10,506,060 due to exotic vegetation removal required for new land acquisitions (Sandhill Crane, John Bills, Jupiter Ranch and Hatcher/Halpryn) that were not anticipated when the contract was executed. Funding availability is based partly on ERM's successes in obtaining State, Federal and mitigation dollars associated with several of the Natural Areas. This purchase is off South Florida Water Management District Contracts #4600000982, 4600000984 and 4600000981due to lack of SBE competition for this commodity. This term contract has two (2) twelve (12) month renewal options.

The County has encumbered \$48,072 (\$4,371/month) during the previous eleven (11) months of the current (12) month term contract. Based upon the projected addition of ninety (90) firefighters, the replacement of gear, and a four percent (4%) increase in unit prices, \$400,000 is needed to meet the County's requirements through the expiration of this twelve (12) month term contract. This is a sole source provider who is not a certified SBE.

The County has encumbered \$848,608 (\$56,574/month) during the previous fifteen (15) months of the current eighteen (18) month term contract, which includes a three (3) month extension pursuant to the Board of County Commissioners' authority and a three (3) month extension pursuant to the Board of County Commissioners' authority. Due to direction from the Board of County Commissioners to re-solicit the previous RFP, Fire Rescue requests a contract extension of six (6) months to					

allow time for a new RFP process and contract award. Fire Rescue anticipates generating \$12,439,024 in collections for billings associated with this six (6) month extension term. Of this amount, the contractor will be paid 6.15% of non-Medicaid gross monthly collections, which is estimated to be a total of \$765,000 (\$63,750/month), and a \$15,000 flat fee. This term contract has no renewal options remaining. This contract was established by a competitive RFP process that allowed up to ten (10) points for SBE participation. HCD received grant funding from the Florida Department of Community Affairs (FDCA) to administer and implement the Disaster Recovery Initiative 3 (DRI-3) Program and to prepare and implement procedures based on the Uniform Relocation Assistance and Real Property Acquisition Act (URA) for the County's CDBG and HOME Programs. One (1) consultant was selected by a competitive process to assist HCD with these programs; however, FDCA requires separate contracts for these two (2) services.

- A. This three (3) year term contract is for the administration and implementation of the County's Disaster Recovery Initiative 3 Program. \$285,000 is required to meet the County's requirements through the expiration of this thirty-six (36) month term contract.
- B. This three (3) year term contract is for the preparation and implementation of the CDBG Program and HOME Program policies and procedures for the County based upon the federal URA Act. \$82,300 is required to meet the County's requirements through the expiration of this thirty-six (36) month term contract.

These term contracts have no renewal options. These contracts were established by one (1) competitive RFP process that allowed up to ten (10) points for SBE participation. No certified SBE participation was offered by the selected awardee.
