I. EXECUTIVE BRIEF
Motion and Title: Staff recommends motion to adopt: A Resolution vacating those certain portions of utility easements lying within tract "S", Yamato Court MUPD, as recorded in Plat Book 110, Pages 158-163, Public Records of Palm Beach County, Florida.
SUMMARY: This petition site is located at the southeast corner of Yamato Road and State Road 7. The petitioner is requesting the vacation because the water lines were installed in a different location and these easements are no longer needed.

Background and Justification: The owner, Temple Beth El of Boca Raton, Inc, a Florida not-for-profit corporation, wants to abandon these certain utility easements because the water lines were installed in a different location. Utility service providers have no objection to the vacation because these easements are no longer needed and replacement easements have been provided.
Utility easements are exempt from the privilege fee requirement in accordance with the Palm Beach County Right-of-Way Abandonment and Plat Vacation Ordinance 86-18, as amended.




