**I. EXECUTIVE BRIEF**

**Motion and Title:** Staff recommends motion to approve: Payment of current and future invoices not to exceed a total of \$6,000 to the Leon County Board of County Commissioners for Palm Beach County's pro-rata share of professional services rendered by Nabors, Giblin & Nickerson in the Criminal Conflict and Civil Regional Counsel litigation styled *Leon County, et al. v. Jeffrey Lewis, et al.*, Second Judicial Circuit Civil Case No. 2008-CA-2475. The current invoice, Invoice No. 4 in the amount of \$307.11 for services rendered February 1-28, 2009, is attached.

**Summary:** Leon County retained Nabors, Giblin & Nickerson to challenge the state law that requires counties to fund the Office of Criminal Conflict and Civil Regional Counsel. In response to the request for other counties to participate in the litigation, the County Attorney recommended that Palm Beach County join and expend up to \$6,000. Palm Beach County was named along with 25 other counties as a plaintiff in the subject action. Past invoices approved to date by the Board of County Commissioners total \$2,299.96. This item requests approval of the itemized Nabors, Giblin & Nickerson invoice attached, as well as approval for payment of future invoices up to the six thousand dollar cap. Payment of the current sum due, \$307.11, will bring the total expended to date to \$2,607.07, leaving an authorized balance of \$3,392.93. Countywide (DMN)

**Background and Justification:** During the 2007 legislative session, the State Legislature created the Office of Criminal Conflict and Civil Regional Counsel. This office was created to provide "adequate representation to persons entitled to court-appointed counsel under the Federal or State Constitution or as authorized by general law" according to Florida State Statute 27.511; i.e., to provide legal services to criminal defendants whom the Public Defender's Office could not represent due to conflicts of interest, and to supervise private court-appointed attorneys in child dependency cases and other civil actions. The result of this legislation is that counties are burdened with funding the Office of Criminal Conflict and Civil Regional Counsel.

Two complaints in Leon County Circuit Court were filed in July 2008 challenging the constitutionality of the new state statute. The first complaint was filed by 25 counties, including Palm Beach County, and the Florida Association of Counties (FAC) against the four Regional Conflict Counsels, as well as the Speaker of the House and the President of the Senate. The second suit was filed by Volusia County alone against the State of Florida and other entities. Both cases have similar issues and were consolidated before the same judge. The Defendants filed a Motion to Dismiss on numerous grounds, which was denied with regard to Palm Beach County, et.al. on October 13, 2008. The motion for summary judgment filed by FACA participating counties was argued in Leon County Circuit Court on December 12, 2008. The judge took the matter under advisement, and on December 18, rendered an order granting the counties' motion. The court ruled in favor of the counties on two counts:

- (1) The court ruled that the portion of the legislation creating the regional conflict counsel that attempts to shift the funding requirements for the regional counsel offices from the state to the counties is unconstitutional and not binding on the counties because it violates Article V, section 14 of the Florida Constitution (relates to state court funding) and because the legislature, in attempting to expand the definition of "public defender" has violated Article V, section 18 of the Florida Constitution (constitutional definition of public defender).
- (2) The court ruled that the funding shift for regional conflict counsel is not binding, under Article VII, section 18 (the unfunded mandate provision) on the counties because the legislature failed to find that the law fulfills an important state interest before attempting the cost shift.

This was a great order for the counties; so much so that the State filed an appeal to the Supreme Court of Florida on January 5, 2009, appealing the District Court's decision of December 18. That appeal is still pending at the time of this writing.



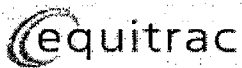
