I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 1 to the annual Contract (R2008-0965) for property development evaluation services with Cotleur & Hearing, Inc. for professional consulting services on a continuing contract basis.

Summary: Cotleur & Hearing, Inc. was selected to provide professional consulting services for property development evaluations. The Board approved an annual contract on June 3, 2008. The original Contract provided for an initial one (1) year term with a one (1) year renewal option. Amendment No. 1 will provide for services during the first and final renewal period. Cotleur & Hearing, Inc. has an SBE participation goal of 94%. During the first year of the Contract, Cotleur & & Hearing, Inc. has achieved 94% participation. (Capital Improvements Division) <u>Countywide</u> (JM)

Background and Justification: In accordance with Board adopted procedures pursuant to Florida Statute 287.055 (Consultants Competitive Negotiation Act), Cotleur & Hearing, Inc. was one of three firms selected to perform professional consulting services on a continuing contract basis. Work is authorized through individual task agreements when required during the term of this contract. The initial contract term is for one year and the original Board action allowed for one additional (1) one year renewal. This amendment would provide services during this renewal period and would be the final renewal year of the contract. It is the consensus of Facilities Development & Operations that Cotleur & Hearing, Inc. has successfully provided the professional services required by the County in a timely manner. They are in good standing and wish to continue to provide professional services. This Amendment will maintain the continuous professional services required by the County. During the first year of the Contract, Cotleur & Hearing, Inc. was awarded \$91,160 in Consultant Service Authorizations.

Annual Planning & Property Development Services

WHEREAS, the parties have entered into a Contract under which the CONSULTANT provided certain professional services to the COUNTY for various projects in accordance with Consultants Competitive Negotiations Act (CCNA) FS 287.055; and

WHEREAS, the parties hereto desire to amend the Contract to extend it for an additional one (1) year period.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants hereinafter set forth and for such other good and valuable consideration, the receipt of which the parties hereto expressly acknowledge, the parties covenant and agree to the following terms and conditions:

1. The term of this Contract as set forth in Section 4, Article 4.1 is renewed for one (1) additional year to June 3, 2010.

2. Except as specifically modified above, the terms and conditions of the Contract are hereby confirmed and remain in full force and effect.
