The County has encumbered \$1,681,869 (\$34,324/month) during the previous forty-nine (49) months of the current sixty (60) month contract. Department of Airports is requesting an increase of \$87,500 over the previously authorized amount of \$1,815,000, which includes the Director of Purchasing's ten percent (10%) funding authority, due to obtaining four (4) new elevators, in addition to the continued requirements for monthly maintenance and needed repairs through contract expiration.
