I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

- A) A Contract with Hardrives, Inc., (Hardrives), the lowest responsive, responsible bidder in the amount of \$1,864,859.45 for the construction of Seminole Pratt Whitney Road Phase 1, from S.R. 80 to South of Okeechobee Boulevard, to perform clearing and grubbing and drainage improvements (Project); and
- **B)** A Budget Amendment of \$1,480 in the Road Impact Fee Fund-Zone 3 to recognize reimbursement funding from AT&T for reimbursable utility work and appropriate it to Seminole Pratt Whitney Road Phase 1, from S.R. 80 to South of Okeechobee Boulevard.

SUMMARY: Approval of this Contract will allow Palm Beach County to issue a Notice to Proceed to begin construction of the Project. The Small Business Enterprise (SBE) goal for the Project is 15% overall. The SBE participation committed for the Project by Hardrives is 15.31%. The time limit for the completion of all work under this contract shall be no more than 240 calendar days. Approval of this Budget Amendment will recognize reimbursement funding from AT&T for reimbursable utility work and appropriate it to the Project account. Following this Project, the utilities will be relocated from the east side to the west side. When that is completed, Palm Beach County will bid out the actual road construction, widening from two to four lanes.

Background and Justification: Bids were received by the Engineering Department on March 3, 2009. Hardrives was the lowest responsive, responsible bidder. The Office of Small Business Assistance issued its SBE evaluation on March 19, 2009.


