I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

A) Amendment No. 3 to the contract with Hedrick Brothers Construction (R2007-1506) in the amount of \$10,696,433 for construction management services for Four Points Renovations, subject to the closing on the loan which will finance this project; and

B) Insurance premium provided under Palm Beach County's Master Builder's Risk Program in an estimated amount not to exceed \$179,700.

Summary: Amendment No. 3 will provide for a Guaranteed Maximum Price (GMP) for 1) replacement of the above ceiling package air conditioning units with a chilled water system, 2) upgrade the building systems to meet current code for a single tenant public owner, 3) harden the entire facility to act as an Emergency Operations Center annex, and 4) make tenant specific renovations to meet operational requirement of users. The Small Business Enterprise (SBE) goal for this project is 15%. Hedrick Brothers Construction will be providing 27.4% SBE participation in this amendment. The duration of this work is 629 calendar days. Financing for this project is from a \$16.2 million loan authorized at the April 21, 2009 BCC meeting. (Capital Improvements Division) Countywide (JM)

Background and Justification: As part of the Facilities Master Plan, two large current occupants of Four Points; Fire-Rescue and Human Resources, have relocated to other locations: Fire-Rescue was relocated to its Administration/Training Facility in November, 2008, and Human Resources relocated to the Airport Center in May, 2009. The vacated space will be utilized for new occupants Head Start Administration, Victim Services (evening use only), and provisions for the Emergency Operations Support Facility (EOCSF). The EOCSF will serve four primary functions when the EOC is activated. It will: (1) provide support facilities (sleeping, dining, lockers/showers, living room) for the entire EOC operation; (2) function as the Emergency Information Center (Consumer Affairs) during and post-event; (3) function as the center for post-disaster operations for Purchasing; and (4) function as the center for Branch 2 post-disaster operations. The needs of the remaining occupants, Purchasing, Office of Small Business, Consumer Affairs, and Youth Affairs, have been reviewed and the areas modified, as necessary. The GMP contains a contingency of \$534,822. The construction will be covered under the County's Master Builder's Risk Insurance policy.



AMENDMENT #3 TO CONTRACT FOR CONSTRUCTION MANAGEMENT SERVICES FOUR POINTS RENOVATIONS PROJECT NO. 07216

WHEREAS, the Owner and Construction Manager (Hedrick Brothers Company, Inc.) acknowledge and agree that the Contract between Owner and Construction Manager dated September 11, 2007 (R-2007-1506) is in full force and effect and that this merely supplements said Contract;

WHEREAS, the parties hereto entered into a Contract between Owner and Construction Manager whereby the Construction Manager has rendered or will render pre-construction services as specified therein; and

WHEREAS, the parties have negotiated a Guaranteed Maximum Price, including Construction Managers fees for construction and warranty services and other services as set forth herein and in the Contract;

WHEREAS, the Construction Manager represents that the Construction Manager, Subcontractors, material and equipment suppliers have compared Phasing, Demolition, Architectural, Structural, Mechanical, Electrical, Plumbing, Civil and Site Drawings and Specifications and have compared and reviewed all general and specific details on the Drawings and that all conflicts, discrepancies, errors and omissions, which are within the commonly accepted knowledge based of a licensed general contractor, subcontractor, trades persons, manufacturers or other parties required to carry out the Work involved in this Amendment, have been corrected or clarified prior to execution of this GMP Amendment to the Contract, and therefore Construction Manager warrants that the GMP (exclusive of contingency) includes the cost of correcting all conflicts, discrepancies, errors, or omissions which Construction Manager identifies, or should have identified through the exercise of reasonable skill and care, during the preconstruction phase of this Contract.

WHEREAS, the Construction Manager's review and comparison of all Drawings has taken into consideration the total and complete functioning of all systems and therefore the Construction Manager represents that the GMP represents the total cost for complete and functional systems.

NOW THEREFORE, in exchange for the mutual covenants and promises set forth herein and the sums of money agreed to be paid by the Owner to the Construction Manager, the parties agree as follows:

GUARANTEED MAXIMUM PRICE

Pursuant to Article 2.2 and Article 6 of the Contract between Owner and Construction Manager, the parties have agreed to the establishment of a Guaranteed Maximum Price of **\$10,696,433** for the construction costs of Four Points Renovations. Refer to Exhibit A.

SCHEDULE OF TIME FOR COMPLETION
 Pursuant to Article 5.3, Construction Manager shall substantially complete the project within 629 calendar days of receiving the Notice to Proceed with construction work from the Owner. Liquidated Damages are \$300/day for failure to complete within the contract time or approved extension thereof.


