### I. EXECUTIVE BRIEF

## Motion and Title: Staff recommends motion to:

A) adopt Resolution for Assistance through Florida Inland Navigation District (FIND) Waterways Assistance Program authorizing submission of a grant application requesting \$824,600 to cover a portion of the costs associated with construction of the South Cove Restoration Project located in the Lake Worth Lagoon and the City of West Palm Beach;

**B)** authorize the County Administrator or his designee to sign the project agreements, all future time extensions, task assignments, certifications and other forms associated with the project agreement, and necessary minor agreements that do not change the scope of work or terms and conditions of the agreements if any or all the grants are approved; and

**C) authorize** the Director of the Department of Environmental Resources Management to serve as Liaison Agent with FIND for this projects.

**Summary:** The County will be submitting a grant proposal which will reimburse the County \$24,600, (31.5%) of the South Cove Restoration project which is currently approved to go forward. If successful in receiving funding, the grant will potentially reduce the County's match requirements from other funding sources depending on the results of the construction bid. The deadline for spending the grant is September, 2012. District 4 (SF)

**Background and Justification:** On December 18, 2007 (R2007-2279) and December 16, 2008 (R2008-2327), the Board approved contracts with Florida Department of Environmental Protection's Lake Worth Lagoon Partnership Program that included \$600,000 and \$415,000 for the South Cove Restoration Project. County matching funds for the grants is a combination of Vessel Registration Fee Dollars, Manatee Funds, and in-kind services. If successful, the FIND grant will potentially reduce County costs for the South Cove Restoration Project. Construction of the project is anticipated to begin in fall of 2009. A Budget Amendment and the executed grant will be submitted to the BCC after it has been approved.

## ATTACHMENT E-6 RESOLUTION FOR ASSISTANCE UNDER THE FLORIDA INLAND NAVIGATION DISTRICT WATERWAYS ASSISTANCE PROGRAM

WHEREAS, THE <u>Palm Beach County Board of County Commissioners</u> is interested in carrying out the following described project for the enjoyment of the citizenry of <u>Palm</u> <u>Beach County</u> and the State of Florida:

Project Title: South Cove Restoration and Boardwalk

Total Estimated Cost <u>\$2,621,400</u>

Brief Description of Project:

The South Cove Restoration project will construct intertidal mangrove and spartina islands on State Submerged Lands that lie to the west of the Intracoastal Waterway (ICW) channel within the Lake Worth Lagoon (LWL). Components of the project will include recreational and environmental educational opportunities to visitors and residents of Downtown West Palm Beach, will improve boating safety by reducing boat wake energy, and will resotre the natural estuarine resources of the lagoon. A 556-foot elevated boardwalk and observation platform will allow visitors a closer view of estuarine tidal flats, oyster reefs, seagrass beds, intertidal mangrove and spartina islands. Kiosk, signage, and educational material will provide information about the site. The islands and oyster reefs will provide protection to the existing seagrass beds in the project vicinity by reducing boat wake and wave energy, producing safer navigable water with the ICW.

The proposed project involves the filling of an existing deep dredge hole to cap muck sediments and create three (3) mangrove/spartina islands totaling 1.7 acres as well as create 3.50 acres of potential seagrass habitat. The project also includes placing limestone boulders to create 1.7 acres of potential oyster reef along the eastward extent of existing seagrasses that are located adjacent to the seawall. The third element of the project includes the construction of four (4) mangrove planters and one (1) spartina planter adjacent to the Flagler Drive seawall providing additional 0.31 acres of mangroves and spartina habitat creating greenspace along an existing vertical bulkhead seawall.

AND, Florida Inland Navigation District financial assistance is required for the program mentioned above,

# NOW THEREFORE, be it resolved by the Palm Beach County Board of County

Commissioners that the project described above be authorized,

AND, be it further resolved that said <u>Palm Beach County Board of County</u> <u>Commissioners</u> make application to the Florida Inland Navigation District in the amount of <u>31.5%</u> of the actual cost of the project in behalf of said <u>Palm Beach County Board of County</u> <u>Commissioners</u>

AND, be it further resolved by the <u>Palm Beach County Board of County Commissioners</u> that it certifies to the following:

Section 1:

1. That it will accept the terms and conditions set forth in FIND Rule 66B-2 F.A.C. and which will be a part of the Project Agreement for any assistance awarded under the attached proposal.

2. That it is in complete accord with the attached proposal and that it will carry out the Program in the manner described in the proposal and any plans and specifications attached thereto unless prior approval for any change has been received from the District.

3. That it has the ability and intention to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said <u>Palm Beach County</u> Board of County Commissioners for public use.

4. That it will not discriminate against any person on the basis of race, color or national origin in the use of any property or facility acquired or developed pursuant to this proposal, and shall comply with the terms and intent of the Title VI of the Civil Rights Act of 1964, P. **PROJECT SUMMARY NARRATIVE (Please summarize the project in 2 paragraphs or less.)** The South Cove Restoration project is located north of the Royal Park Bridge adjacent to Flagler Drive in the City of West Palm Beach and immediately west of the Intracoastal Waterway (ICW) channel. Components of the project will include recreational and environmental educational opportunities to visitors and residents of Downtown West Palm Beach, will improve boating safety by reducing boat wake energy, and will restore the natural estuarine resources of the lagoon. A 556-foot elevated boardwalk and observation platform will allow visitors a closer view of estuarine tidal flats, oyster reefs, seagrass beds, intertidal mangrove and spartina islands. Kiosk and educational material will provide information about the sites. The islands and oyster reefs will provide protection to the existing seagrass beds in the project vicinity by reducing boat wake and wave energy, producing safer navigable waters within the ICW.

The South Cove Restoration project will provide critical shallow water habitat for fisheries and wildlife that have been lost due to extensive dredging, filling and seawall construction in the LWL. The project involves the filling of an existing deep dredge hole to cap muck sediments and create three (3) mangrove/spartina islands totaling 1.7 acres as well as create 3.5 acres of seagrass habitat. The project also includes placing limestone boulders to create 1.7 acres of oyster reef habitat along the eastward extent of existing seagrasses. The oyster reef will prevent scouring and loss of seagrass, reduce boat wake in the area, and provide suitable substrate for oyster recruitment. In addition to the mangrove islands, the project will include four (4) mangrove planters and one (1) spartina planter adjacent to the Flagler Drive seawall. These planters will provide an additional 0.3 acres of greenspace along an existing vertical bulkhead seawall.

The facility will provide an increase in both recreational and environmental educational opportunities to visitors and residents of downtown West Palm Beach. The project will incorporate kiosks and educational signage along a 556ft elevated boardwalk with one 16ft by 16ft kiosk platform attached to a 16ft x 16ft observation platform to allow greater viewing of the LWL waterfront and project area. The South Cove restoration project will provide local schools and universities a "living classroom" to observe various estuarine habitats at one location.

### 2) WATERWAY RELATIONSHIP:

# a) Explain how the project directly relates to the ICW and the mission of the Navigation District.

This project is adjacent to and directly west of the ICW, in an urban area of the LWL, that currently experiences high speed boat traffic generating boat wakes that reflect off the vertical bulkhead seawall. This project will fill a large anoxic dredge hole, cap muck sediments and bring up elevations to a height that will support seagrass growth at the same time creating critical shallow water habitat, intertidal mangrove and spartina islands, and oyster reef habitat all reducing boat wake energy in the area. This facility will also offer visitors and residents of West Palm Beach both recreational and educational opportunities, informational signs about the ICW, LWL and the project will posted on kiosks on the boardwalk.

# b) How does the project benefit public navigation or access to the ICW or adjoining waterways?

The project will greatly improve safe boating navigation in the ICW with the creation of the intertidal islands and oyster reef which will reduce boat wake energy in an area that currently has a vertical bulkhead seawall. The project area will be utilized by fisherman in small boats, provide a safe boating area for kayaks and canoes, and provide pedestrians access for waterfront viewing of the lagoon.

# a) How is the public usage of this project clearly identified and quantified?

The project has been designed with the intent of restoring a highly urbanized area of the lagoon that receives high visitor traffic due to its proximity to downtown West Palm Beach. This project will also create public awareness about the natural resources within the LWL, and allow all residents and visitors to Palm Beach County to enjoy the waterfront project through the access of a boardwalk and observation deck that will provide greater public knowledge and access to the lagoon. The project will act as a "living classroom" that will showcase the various estuarine habitats of the lagoon at the same time providing an improved recreational area to fish, canoe, kayak, or enjoy the waterfront.

# b) Discuss the regional local public benefits and access to be provided by the project.

The LWL is heavily urbanized estuarine system that has lost over 70% of its natural resources over the past 50 years. This project will restore a critical shallow water habitat, improve water quality, and provide both educational and recreational opportunities to downtown West Palm Beach's waterfront.

## c) Estimate the amount of total public use.

The South Cove Restoration Project is located in downtown West Palm Beach along Flagler Drive, just north of Royal Palm Bridge south of the Meyer Amphitheater. This area is used for many public events and festivals throughout the year, such as SunFest Music and Art Festival, Palm Beach Boat Show, Fourth on Flagler, Marathon of the Palm Beaches; these events attract tens of thousands of participants annually. This project will be the Palm Beach County's most visible estuarine restoration project both by water and land due to the proximity to West Palm's downtown area, the restoration area and boardwalk is expected to be used daily by both Palm Beach County residents and visitors.

This facility will be able to be used and enjoyed by all residents and visitors to the area.

To decrease the cost of the project Palm Beach County may utilize fill material from the Palm Harbor Marina expansion project to create the intertidal islands. The intertidal islands and oyster reefs will not only provide improve habitat for the wildlife of the LWL but provide needed wake attrition for boater traveling along the ICW. The recruitment of oysters along with the capping of the muck sediments in the existing hole will improve water quality conditions within the project area

# b) Clearly demonstrate how the project will continue to be maintained after District funding is completed.

Palm Beach County and The City of West Palm Beach may execute an Interlocal Agreement for Palm Beach County to construct and monitor the natural resources associated with the project, and the City of West Palm Beach to provide the required maintenance and security associated with the boardwalk and observation deck in perpetuity.

# c) Will the program result in significant and lasting benefits? Please describe any environmental benefits associated with this project.

This project will create and improve an important estuarine habitat in an urban portion of the lagoon by filling in a deep anoxic dredge hole that will cap muck sediments that are currently resuspended in the water column with wind and wave generating activities, improving water quality in this area. The enhanced habitat will recruit a variety of wildlife from juvenile fish, invertebrates, oysters, wading birds, and provide habitat for manatees. This project will create critical shallow water habitat that has been lost due to extensive dredging, filling, and seawall construction activities over the past 50 years within the lagoon.

### 8) PROJECT DESIGN:

The project design and surveys associated with the South Cove Restoration and Boardwalk project have been completed. Project is ready for construction.

The boardwalk has been designed to showcase the various estuarine habitats of the lagoon. The project has been designed to enhance the current resources of the area; by capping the muck sediments, creating the seagrass, intertidal, and oyster habitat, all which will provide important shallow water habitat and improve the water quality of the area. The County will explore options to utilize spoil material generated from other construction projects that may significantly reduce the cost of the project; including Palm Harbor Marina expansion, Juno Dunes NA, site MSA 614B, or any other projects that may be able to supply sand.

#### 9) CONSTRUCTION TECHNIQUES:

The dredge holes will be filled using mechanical methods with a clam shell excavator placing the sand from a barge. Local volunteers will be used to plant all the mangroves and spartina on the intertidal islands and seawall planters.

Land-based construction and shallow draft barge use will minimize environmental impacts. The simplified design will reduce construction costs.

Brief Description of Project:

The South Cove Restoration project will construct intertidal mangrove and spartina islands on State Submerged Lands that lie to the west of the Intracoastal Waterway (ICW) channel within the Lake Worth Lagoon (LWL). Components of the project will include recreational and environmental educational opportunities to visitors and residents of Downtown West Palm Beach, will improve boating safety by reducing boat wake energy, and will resotre the natural estuarine resources of the lagoon. A 556-foot elevated boardwalk and observation platform will allow visitors a closer view of estuarine tidal flats, oyster reefs, seagrass beds, intertidal mangrove and spartina islands. Kiosk, signage, and educational material will provide information about the site. The islands and oyster reefs will provide protection to the existing seagrass beds in the project vicinity by reducing boat wake and wave energy, producing safer navigable water with the ICW.

The proposed project involves the filling of an existing deep dredge hole to cap muck sediments and create three (3) mangrove/spartina islands totaling 1.7 acres as well as create 3.50 acres of potential seagrass habitat. The project also includes placing limestone boulders to create 1.7 acres of potential oyster reef along the eastward extent of existing seagrasses that are located adjacent to the seawall. The third element of the project includes the construction of four (4) mangrove planters and one (1) spartina planter adjacent to the Flagler Drive seawall providing additional 0.31 acres of mangroves and spartina habitat creating greenspace along an existing vertical bulkhead seawall.

- The South Cove Natural Area is designated as a high-priority restoration project in the Lake Worth Lagoon Management Plan. This project will provide critical shallow water habitat and improve water quality.
- Fill anoxic (lacking-oxygen) dredge holes with 175,000 cubic yards of fill to create three intertidal mangrove/spartina islands.
- Create 2 acres of mangrove and spartina habitat, 3.5 acres of potential seagrass habitat, and 0.9 acres of oyster reef.
- Construct a 556-foot elevated boardwalk, 16' x 16' observation deck and educational kiosk for public use.
