I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

A) adopt a Resolution authorizing the extension of the term of the License Agreement (R2007-1103) with the Genealogical Society of Palm Beach County, Inc., and finding that the purpose of the First Amendment is promoting community interest and welfare, the space is required for such use and is not needed for County purposes; and

B) approve a First Amendment to License Agreement with the Genealogical Society of Palm Beach County, Inc. to provide for automatic renewals of the term of the License Agreement on a year to year basis, unless terminated by either party upon 180 days notice.

Summary: On July 10, 2007, the Board approved a License Agreement with the Genealogical Society of Palm Beach County, Inc. d/b/a Palm Beach County Genealogical Society, for use of 1,719 SF of space in the County's Main Library located at 3650 Summit Boulevard in the City of West Palm Beach. The current License Agreement will expire July 9, 2009. This First Amendment: (i) extends the term for one (1) year from July 10, 2009 through July 9, 2010, with automatic annual renewals thereafter, unless cancelled by either party upon 180 days notice; (ii) acknowledges that the correct square footage is 1,719 SF; (iii) modifies Section 3.05 of the License Agreement to prohibit discrimination against any individual based upon gender identity or expression; and (iv) updates the Notice provisions. The Genealogical Society will continue to pay a monthly service fee of \$150.00 for utility and custodial costs. All other terms and conditions of the License Agreement remain unmodified. (PREM) District 2 (HJF)

Background and Justification: The License Agreement provided for an initial term of two (2) years, with three (3) one (1) year options to renew in the County's sole discretion. The initial term of the License Agreement expires July 9, 2009, and the Society has requested an extension with automatic one (1) year renewals.

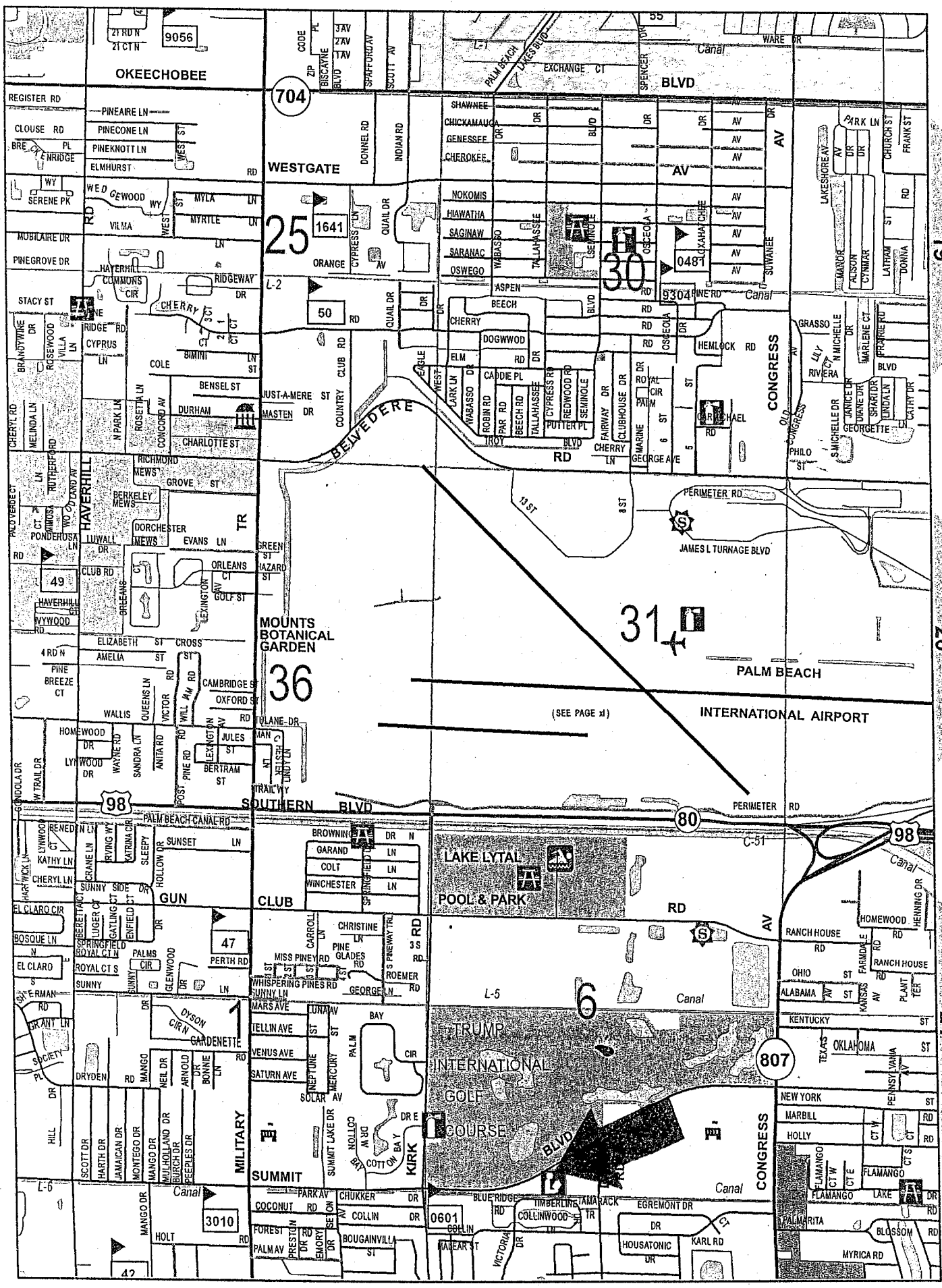

RESOLUTION NO. 2009-_____

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE AMENDMENT OF A LICENSE AGREEMENT FOR THE USE OF SPACE WITHIN A COUNTY-OWNED BUILDING BY THE GENEALOGICAL SOCIETY OF PALM BEACH COUNTY, INC. A FLORIDA NOT FOR PROFIT 501 (C)(3) EDUCATIONAL ORGANIZATION, PURSUANT TO FLORIDA STATUTE SECTION 125.38; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Genealogical Society of Palm Beach County, Inc. (f/k/a and d/b/a Palm Beach County Genealogical Society, Inc.), a Florida not for profit 501(c)(3) educational organization ("Licensee"), has made application to the Board of County Commissioners of Palm Beach County requesting that Palm Beach County amend its License Agreement (R2007-1103), which Agreement allows Licensee use of space within the Main Library, to provide for automatic renewals of the term of the License Agreement;

WHEREAS, Licensee uses the licensed space at the Main Library to make genealogical research materials and services available to the public;

WHEREAS, genealogy research is one of the most popular services offered at the Main Library;

WHEREAS, the Board of County Commissioners of Palm Beach County hereby finds that Licensee, a non-profit organization, is organized for the purpose of promoting community interest and welfare, the aforementioned use constitutes a use for the community interest and welfare, the space within the library is required for such use, and such space is not needed for County purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. Recitals

The foregoing recitals are true and correct and incorporated herein by reference.

Section 2. Authorization to License Real Property

The Board of County Commissioners of Palm Beach County shall license to Licensee, pursuant to the License Agreement as amended by the First Amendment to License Agreement

attached hereto and incorporated herein by reference, for a term that automatically renews annually unless terminated by either party, and for a monthly service fee of \$150.00 for utilities and custodial costs, the space identified in the License Agreement for the use identified above.

Section 3. Conflict with Federal or State Law or County Charter.

Any statutory or Charter provisions in conflict with this Resolution shall prevail.

Section 4. Effective Date.

The provisions of this Resolution shall be effective immediately upon adoption hereof.

FIRST AMENDMENT TO LICENSE AGREEMENT

THIS FIRST AMENDMENT TO LICENSE AGREEMENT ("First Amendment"), made and entered into _____, by and between **PALM BEACH COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as "County", and **GENEALOGICAL SOCIETY OF PALM BEACH COUNTY, INC.**, f/k/a **PALM BEACH COUNTY GENEALOGICAL SOCIETY, INC.**, a not for profit 501(c)(3) educational organization with a federal identification number of 237107721, hereinafter referred to as "Licensee".

WITNESSETH:

WHEREAS, County and Palm Beach County Genealogical Society, Inc., entered into that certain License Agreement dated July 10, 2007 (R2007-1103) (the "Agreement") for use of the Premises, as defined in the Agreement, for a term of two (2) years; and

WHEREAS, Palm Beach County Genealogical Society, Inc., changed its name to Genealogical Society of Palm Beach County, Inc., in 2008, but is also continuing to do business as Palm Beach County Genealogical Society; and

WHEREAS, the Agreement provided Licensee with the option to renew, at County's sole discretion, for three additional one (1) year terms; and

WHEREAS, County and Licensee desire to amend the Agreement to provide for automatic renewals of the term of the Agreement.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The above recitals are true and correct and incorporated herein by reference. Terms not defined or amended herein shall have the same meaning as ascribed to them in the Agreement.

2. The term of this Agreement is hereby extended for a period of one (1) year commencing on July 10, 2009, and expiring on July 9, 2010, and shall automatically be extended on a year-to-year basis (July 10 through July 9), unless terminated as set forth herein. Either party hereto may notify the other party at any point during the term, or any extension thereof, of the notifying party's election to terminate the Agreement. The notifying party shall provide the other party with at least one hundred eighty (180) days advance written notice of its election to terminate the Agreement upon the date set forth in the termination notice.

3. The parties acknowledge that the square footage of the Premises as set forth in Section 1.01 of the Agreement is incorrect. The correct square footage of the Premises is 1,719 square feet.

4. Section 3.05 of the Agreement is modified to also prohibit discrimination against any individual on the basis of gender identity or expression.

5. Section 8.02 (b) is deleted in its entirety and replaced with the following:

7. Except as set forth herein, the Agreement remains unrevised and in full force and effect, and the parties hereby ratify, confirm, and adopt the Agreement as amended hereby.

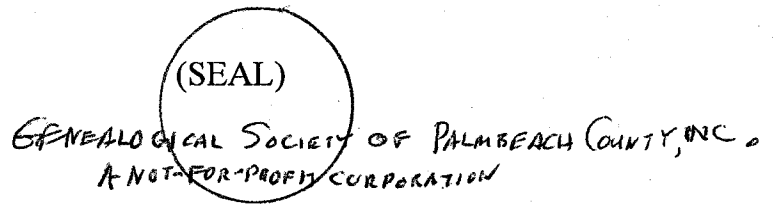

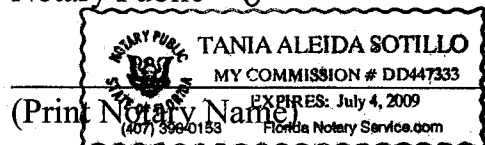

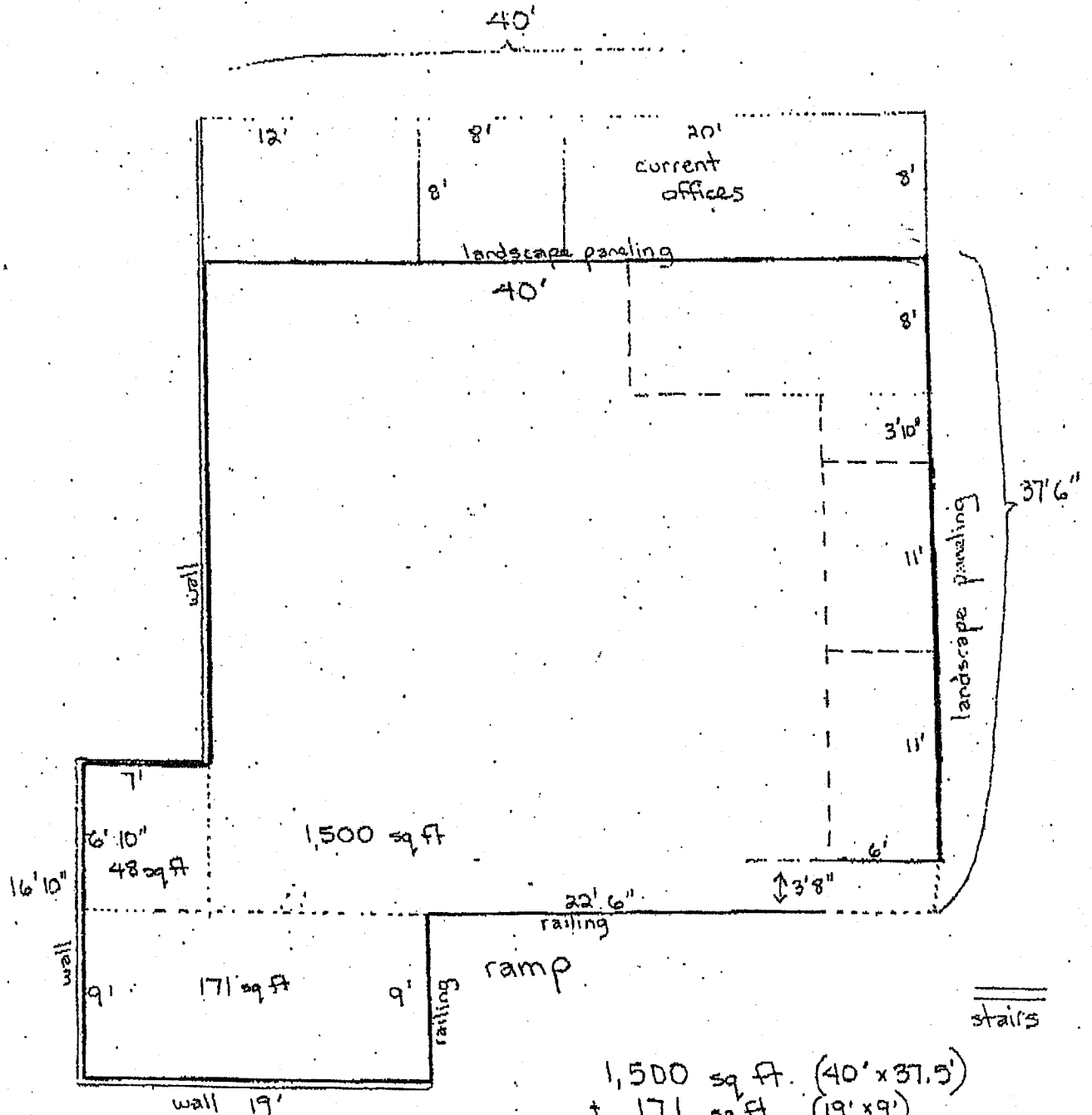

Genealogy Library space

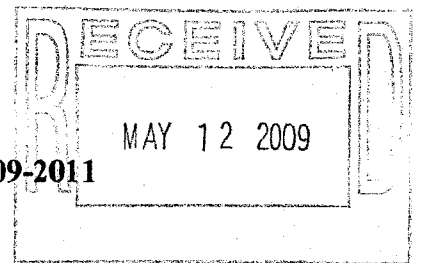

5. If we should fall under Florida's requirement for carrying Workers Compensation insurance, we shall immediately obtain such coverage and provide evidence of it to you.

Accordingly, we hereby apply for exemption from Palm Beach County's requirement for carrying Workers Compensation insurance.
