AMENDMENT #1 TO ANNUAL DEMOLITION CONTRACT

This agreement amends the contract between Palm Beach County (County) and The BG Group, LLC (Contractor) authorized pursuant to Palm Beach County Resolution (R-2008-1055).

The original contract provided that Contractor would act as an annual Demolition contractor from June 17, 2008 to June 16, 2008 or until the total dollar value of work authorizations issued in the term totals five hundred thousand dollars (\$500,000), whichever occurred first. That contract also provides that it could be extended for four additional terms.

The County is extending the contract for a period of twelve (12) months based on expiration of the term. Pursuant to the provisions of the existing contract, the parties agree that Contractor will continue to act as an annual Demolition contractor until June 15, 2010 or until the total dollar value of work authorizations for the second term totals five hundred thousand dollars (\$500,000), whichever comes first. The parties agree that the total dollar value of work authorizations issued pursuant to this amendment shall not exceed five hundred thousand dollars (\$500,000).

Except as amended herein, all provisions of the existing contract shall remain in full force and effect.
