I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

- A.) Approve Addendums to the standard form Category "B" Grant Agreement and Category "CII" Grant Agreement to provide "TDC stimulus" funding for out-of-county marketing of Cultural programs;
- B) Authorize The County Administrator or his designee to execute the Addendum with grantees.

Summary: These Addendums to the Category "B" and "CII" grant agreements will provide the terms and conditions of grantees' receipt of additional 'stimulus' funding for marketing and advertising their Cultural programs to promote Palm Beach County tourism. Countywide (MC)

Background and Justification: The Palm Beach County Cultural Council administers the Category "B" and "CII" grant programs for the TDC. Each year, after approval by the Cultural Council and the TDC, recipients of the grants enter into standard agreements with the County to provide the terms and conditions of "bed tax" funding of their cultural programs with execution of the agreement by the Executive Director of the Tourist Development Council.

This year, as part of the TDC Stimulus Program, the County has made additional monies available to cultural grantees for the out-of-county marketing of their programs. The attached agreement will be an Addendum to the Grant Agreement to provide for the additional marketing dollars. Upon approval by the TDC, the Addendum for each recipient will be executed by the Executive Director of the TDC on behalf of the County.

WHEREAS, the County has contracted with the Palm Beach County Cultural Council, hereinafter "Cultural Council", to carry out certain functions for the County's Tourist Development Plan which duties include the administration of Category B cultural grants for programs that promote Palm Beach County tourism; and
WHEREAS, Grantee was selected as a recipient of a Category B grant and entered into an agreement, hereinafter "Grant Agreement", whereby the County provided funding from Tourist Development Tax ("bed tax") revenues for Grantee's cultural program; and
WHEREAS, the County has made available additional monies ("stimulus program") to fund the out-of-county marketing and advertising of cultural programs to assist in the promotion of Palm Beach County tourism during the current downturn in the economy; and
WHEREAS, the Grantee has been identified as a recipient of "stimulus program" funding for the out-of-county marketing and advertising of its program; and
