I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 1 to the contract (R2007-1807) with Handex Consulting & Remediation – Southeast, LLC., for environmental assessment services on a continuing contract basis.

Summary: Handex Consulting & Remediation – Southeast, LLC., was selected to provide professional consulting services for Annual Environmental Assessment Services. The original contract provided for an initial two (2) year term with two (2) - one (1) year renewal options. Amendment No. 1 will provide for services during the first renewal period. Handex Consulting & Remediation – Southeast, LLC., has a Small Business Enterprise (SBE) participation goal of 20%. During the two years of the contract, Handex Consulting & Remediation – Southeast, has achieved 44.6% participation. (Capital Improvements Division) Countywide (JM)

Background and Justification: In accordance with Board adopted procedures pursuant to Florida Statute 287.055 (Consultants Competitive Negotiation Act), Handex Consulting & Remediation – Southeast, LLC., was one of three firms selected to perform professional consulting services on a continuing contract basis. Work is authorized through individual task agreements when required during the term of this contract. The initial contract term is for two years and the original Board action allowed for two additional (1) one year renewals. Amendment No. 1 will provide services during the first renewal period and would be the third year of the contract. It is the consensus of Facilities Development & Operations that Handex Consulting & Remediation – Southeast, LLC., has successfully provided the professional services required by the County in a timely manner. They are in good standing and wish to continue to provide professional services. Amendment No. 1 will maintain the continuous professional services required by the County. During the two years of the contract, Handex Consulting & Remediation-Southeast, LLC., was awarded \$32,881 in Consultant Service Authorizations.

- Except as specifically modified above, the terms and conditions of the
 Contract are hereby confirmed and remain in full force and effect.
