ORDINANCE NO. 2009-_____

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, REPEALING ORDINANCE NO. 04-042, AS CODIFIED IN SECTIONS 2-166 THROUGH 2-172 OF THE PALM BEACH COUNTY CODE; WHICH RE-ESTABLISHED THE ADMINISTERING BOARD OF THE COMMUNITY ACTION COUNCIL; PROVIDING FOR REPEAL OF LAWS IN CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE OF LAWS AND ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida determined that it was in the public interest to be designated as a Community Action Council and to appoint an administering board pursuant to the Economic Opportunity Act of 1964; and

WHEREAS, there is a requirement pursuant to rules regulating the Community Services Block Grant Program to have a Community Services Block Grant Advisory Committee, but there is no longer a requirement for such committee to be created by ordinance; and

WHEREAS, the administering board of the Community Action Council acted in the capacity of the Community Services Block Grant Advisory Committee; and

WHEREAS, the Board of County Commissioners now wishes to repeal the referenced ordinance relating to the Community Action Council, and to re-establish a Community Services Block Grant Advisory Committee by a contemporaneous resolution.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

SECTION 1. REPEALER:

Ordinance No. 04-042 is hereby repealed.

SECTION 2. REPEAL OF LAWS IN CONFLICT:

All local laws and ordinances in conflict with any provisions of this Ordinance are hereby repealed to the extent of such conflict.

SECTION 3. SEVERABILITY:

If any section, paragraph, sentence, clause, phrase, or word of this Ordinance is for any reason held by a Court of competent jurisdiction to be unconstitutional, inoperative, or void, such holding shall not affect the remainder of this Ordinance.

1 **SECTION 4. INCLUSION IN THE CODE OF LAWS AND ORDINANCES:**

2 The provisions of this Ordinance shall become and be made a part of the Palm
3 Beach County Code. The sections of this Ordinance may be renumbered or relettered to
4 accomplish such, and the word "ordinance" may be changed to "section," "article," or
5 other appropriate word.

6 **SECTION 5. CAPTIONS:**

7 The captions, section headings, and section designations used in this Ordinance
8 are for convenience only and shall have no effect on the interpretation of the provisions of
9 this Ordinance.

10 **SECTION 6. EFFECTIVE DATE:**

11 The provisions of this Ordinance shall become effective upon filing with the
12 Department of State.
