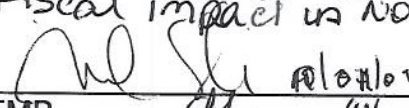
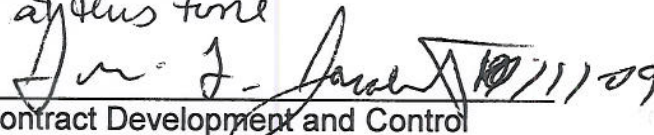

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY SUPPORTING THE ESTABLISHMENT OF THE YOUTH BUILD USA PROGRAM AT THE RIVIERA BEACH MARITIME ACADEMY.

WHEREAS, on June 17, 2009, The City Council of the City of Riviera Beach adopted a Resolution supporting the implementation of the Youth Build USA Program at the Maritime Academy, and authorizing city staff to collaborate with the Maritime Academy in the implementation of the Youth Build USA Program; and

WHEREAS, the Youth Build USA Program recruits unemployed and undereducated young people ages 18-24 to work towards passing the GED examination or receiving a high school diploma while learning work and social skills by building affordable housing for homeless and low-income people; and

WHEREAS, the Riviera Beach Youth Build Program consists of six major program components including housing, education, job training and employability skills, leadership development, counseling and mentoring, and graduate support; and

WHEREAS, the Riviera Beach Youth Build Program is an innovative program designed to unleash the intelligence and positive energy of low-income youth, to rebuild the community and their own lives with a commitment to work, education, family and citizenship.
