**AMENDMENT #3 TO ANNUAL RESIDENTIAL CONTRACT**

This agreement amends the contract between Palm Beach County (County) and DCOTA Contracting, Inc. (Contractor) authorized pursuant to Palm Beach County Resolution (R2006-2218)

The original contract provided that Contractor would act as an annual residential contractor from October 17, 2006 to October 16, 2007 or until the total dollar value of work authorizations issued in the term totals \$499,999.99, whichever occurred first. That contract also provides that it could be extended for four additional terms. This amendment is the third extension. This contract was amended on October 16, 2007 and again on October 21, 2008.

The County is extending the contract for a period of twelve (12) months based on expiration of the current term. Pursuant to the provisions of the existing contract, the parties agree that Contractor will continue to act as an annual Residential Contractor until October 20, 2010 or until the total dollar value of work authorizations for the fourth term totals \$499,999.99, whichever comes first. The parties agree that the total dollar value of work issued pursuant to this amendment shall not exceed \$499,999.99 annually.

Except as amended herein, all provisions of the existing contract shall remain in full force and effect.
