### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** payment to Arthur J. Gallagher Risk Management Services, Inc. in the amount of \$197,441.69 for the purchase of insurance for the Glades Utility Authority (Authority) for the period October 1, 2009, to October 1, 2010, the cost of which will be charged back to the Authority.

**Summary:** In accordance with the Operating Agreement (R2009-1345) approved by the Board of County Commissioners on August 18, 2009, the Water Utilities Department (Department) is responsible for the day-to-day operations of the Authority. Authority operating costs are included in the Department's 2010 budget, and Authority costs will be charged back monthly to the Authority. The Department has worked with the County's Risk Management Department and the County's insurance broker to obtain the necessary insurance for the GUA. The amount to be paid is significantly under the budgeted amount of \$397,000, indicating that the economies of scale expected from the establishment of the GUA are being realized. The insurance being purchased includes property, general liability, commercial auto, public entity liability, crime, and fuel tank liability. <u>Countywide</u> (MJ)

**Background and Justification:** As a separate entity, the Authority is required to have its own insurance coverage. The insurance being purchased will provide all of the necessary coverage for the FY 2009-2010 fiscal year.
