# **Novation Agreement**

This NOVATION AGREEMENT ("Novation") is made and entered into as of \_

\_\_\_\_\_, 2009 ("Effective Date"), between United Parcel Service, Inc., a corporation organized and existing under the laws of the State of Ohio (hereinafter referred to as "Transferor"), United Parcel Service Co., a corporation organized and existing under the laws of the State of Delaware (hereinafter referred to as "Transferee"), and Palm Beach County, a political subdivision of the State of Florida ("County").

WHEREAS, Transferor and County have heretofore entered into that certain Airfreight Building Lease dated November 20, 1996 (R-96-2014-D), which remains in full force and effect, as amended or otherwise modified, to the date hereof (hereinafter referred to as the "Agreement") and the defined terms therein being used with the same meaning.

NOW THEREFORE, in consideration of the mutual covenants herein contained, the parties agree as follows:

Transferor, Transferee and County hereby agree to this Novation and accordingly, that all of the rights, duties and obligations of Transferor under the Agreement are hereby transferred to Transferee as of the Effective Date. County recognizes Transferee as Transferor's successor in interest in and to all of Transferor's rights, duties and obligations under the Agreement as if the Transferee were the original party to the Agreement. The Transferee ratifies all previous actions taken by the Transferor with respect to the Agreement, with the same force and effect as if the action had been taken by the Transferee. Following the Effective Date of this Novation, the term "LESSEE" as used in the Agreement, shall refer to the Transferee.

In all other aspects the terms, conditions and charges of the Agreement shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto have caused this Novation to be duly executed in triplicate by their respective authorized officers as of the Effective Date.
