## I. EXECUTIVE BRIEF

**Motion and Title:** Staff recommends motion to receive and file: First Amendment to Agreement (R2009-1011) with the Town of Lantana for operational costs for the Lantana Sports Complex to extend the project completion date from July 31, 2009, to August 31, 2009.

**Summary:** This fully executed First Amendment to Agreement extends the project completion date for the completed Lantana Sports Complex project in order to allow the County to continue with the reimbursement process. The reimbursement request was received before the deadline date of October 31, 2009, but the project end date needs to be extended to allow for reimbursement of all eligible project expenses. All other terms of the Agreement, including the funding amount of \$14,000, remain the same. Funding for the project is from the Recreation Assistance Program (RAP) District 3 Funds. District 7 (AH)

**Background and Justification:** Resolution R2005-1738 was adopted by the Board on September 13, 2005, to streamline the RAP reimbursement process. It establishes terms and conditions for amending RAP projects and delegates authority for the execution of the amendments to the County Administrator or his designee, which is the Director of the Parks and Recreation Department. The criteria for delegated signature of amendments on behalf of the Board include:

- Changes in project scope/elements within the intent of the approved RAP project;
- Adjustments in budgetary line items within the intent of the approved RAP Project which do not change the contractual amount;
- Changes to the approved project time frame including the initiation date and/or project completion date for periods of less than one year; and
- Other miscellaneous modifications approved by the awarding Commissioner within the overall intent of the approved RAP project.

This delegation of authority allows for more efficient and timely reimbursements for RAP projects by streamlining the existing RAP process for amendments to agreements. The attached Amendment meets criteria listed above, and was executed on behalf of the Board of County Commissioners by the Director of the Parks and Recreation Department.

# FIRST AMENDMENT TO AGREEMENT BETWEEN PALM BEACH COUNTY AND THE TOWN OF LANTANA FOR OPERATIONAL COSTS FOR THE LANTANA SPORTS COMPLEX

THIS AMENDMENT is entered into on <u>Outpus</u>, by and between Palm Beach County, a political subdivision of the State of Florida, hereinafter referred to as "County", and the Town of Lantana, a Florida Municipal Corporation, herein referred to as "Lantana".

### WITNESSETH:

WHEREAS, on June 16, 2009, County entered into an Agreement (R-2009-1011) with Lantana, hereinafter referred to as the "Agreement" to provide Recreation Assistance Program (RAP) funding in an amount not to exceed \$14,000 to assist Lantana with operational costs for the Lantana Sports Complex, hereinafter referred to as the "Project"; and

WHEREAS, Lantana has requested that County change the completion date of the project from July 31, 2009, to August 31, 2009 in order to allow for the reimbursement of all project expenses; and

WHEREAS, the Project will benefit all citizens of Palm Beach County.

**NOW THEREFORE**, the parties hereby agree as follows:

- 1. Section 10 of the Agreement is amended to read "Lantana shall complete the project by August 31, 2009, and invoices and checks and/or proof of payments submitted for reimbursement must be dated within the Project time frame of April 1, 2009, through August 31, 2009. Lantana shall provide its final reimbursement request(s), including a project completion statement and reimbursement documentation as indicated in Section 2 above on or before October 31, 2009."
- 2. Except as provided herein, each and every other term of the Agreement shall remain in full force and effect and the Agreement is reaffirmed as modified herein.
