I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: An annual contract with Knight Electric Co., Inc., to perform electrical contracting services on an as-needed basis for projects typically under \$100,000 each.

Summary: This contract is for one (1) year and is an indefinite-quantity contract with a maximum value of \$1,000,000. The contract will terminate when a total of \$1,000,000 in work orders is issued among the pool of approved electrical contractors or when the one-year time period has expired, whichever occurs first. The contract provides for up to four (4) – one (1) year renewals, each for a not-to-exceed amount of \$1,000,000.00, at the sole option of the County. Staff will review the status of the contractor's certifications annually, prior to renewal, to ensure the firm remains qualified under the original pre-qualification criteria. The work is to be awarded as work orders on a lump-sum, competitively quoted basis among the pool of six (6) electrical contractors. Any work performed will be in accordance with the Contract. The specific magnitude of the work shall be determined by individual work orders. The Small Business Enterprise (SBE) goal is 15%, and will be tracked cumulatively for each work order issued. Knight Electric Co., Inc. is a certified SBE Contractor and is a Palm Beach County company. This is a bond-waiver contract. The cumulative value of active work orders at any time will be limited to \$200,000 per contractor. (FD&O Admin) Countywide (JM)

Background and Justification: Bids were opened on October 15, 2009, for "Annual Contract: Electrical" and Knight Electric Co., Inc. was one (1) of six (6) electrical contractors to submit a pre-qualification package that met the established criteria for acceptance as one of our Annual Electrical Contractors. The contract is effective for a period of twelve (12) months or at the point where the maximum potential contract amount of \$1,000,000 is reached among this pool of six (6) Annual Electrical Contractors
