# AMENDMENT NO. 3 TO FOOD AND BEVERAGE SERVICES AGREEMENT WITH ARAMARK SPORTS AND ENTERTAINMENT SERVICES, LLC

This Amendment No. 3 (the "Amendment") is made this \_\_\_\_ day of \_\_\_\_\_, 2009, to the Food and Beverage Services Agreement, Palm Beach County Convention Center hereinafter "Agreement" (2007-1627) dated October 1, 2007, as amended, by and between the Board of County Commissioners of Palm Beach County, a political subdivision of the State of Florida, hereinafter "County", and Aramark Sports and Entertainment Services, LLC, a limited liability company organized under the laws of the State of Delaware and authorized to do business in the State of Florida, a successor by conversion of Aramark Sports and Entertainment Services, Inc., hereinafter referred to as "Contractor" whose Federal Employer Identification Number is 23-1664232.

#### **RECITALS**

WHEREAS, the County entered into an Agreement and subsequent amendments with Contractor whereby Contractor would provide food and beverage services for the Palm Beach County Convention Center in West Palm Beach, Florida, which Agreement is scheduled to terminate on December 31, 2009; and

WHEREAS, the County had undertaken a competitive process for the selection of a contractor to provide future food and beverage services in the Convention Center; and

WHEREAS, the County declared it necessary to cancel the RFP#2009-CC for the solicitation of Food and Beverage Operations Services at the Convention Center; and

WHEREAS, the County will again solicit bids for Food and Beverage Operations Services at the Convention Center; and

WHEREAS, the County and Contractor wish to extend the term of the Agreement for six months (January through June, 2010) to provide for Aramark to continue providing food and beverage services until the County has completed the selection process.

NOW, THEREFORE, in consideration of the mutual covenants hereinafter contained, and intending to be legally bound, the parties agree that the Agreement dated October 1, 2007, as amended, by and between the County and Contractor shall be further amended as follows:

- 1. Article 2, <u>TERM</u>, of the Agreement is deleted in its entirety and replaced with the following amended Article 2:
  - The term of this Agreement ("Term") shall continue on for six months beginning on January 1, 2010 until June 30, 2010.
- 2. Any and all provisions of the Agreement as amended shall remain in full force and effect. (Signatures begin on following page.)
