### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A) a Partial Release of Lease 4452; and B) a Partial Release of Sublease 4452-01 with the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida (BOT) and Florida Atlantic University Board of Trustees (FAUBT).

Summary: Palm Beach County entered into a Sublease Agreement with Florida Atlantic University and a Lease Agreement with the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida for the Scripps Temporary Facility No. 1 (T1). Scripps has vacated T1, therefore the BOT and FAUBT have requested a release of the lease and sublease. FAU has fulfilled their repayment obligation under the Scripps Temporary Funding Agreement and complied with its obligations under the Funding Agreement, the Primary Lease and Sublease. District 1 (HJF)

Background and Policy Issues: Palm Beach County and FAU entered into a Temporary Facility Funding Agreement, as an exhibit to the Scripps Grant Agreement to facilitate construction of a laboratory and research facility on Subleases' J.D. Campus, for the purpose of housing Scripps Florida until their permanent facilities were complete. Scripps permanent facilities are now complete and Scripps has fully vacated T1.


