I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: A) approve Third Amendment to Grant Agreement with the Palm Beach Metropolitan Planning Organization (MPO) to increase funding from \$100,000 to \$130,000 for funding of the design, permitting, and construction of a water taxi facility at DuBois Park; B) approve a Budget Transfer of \$30,000 in the Metro Planning Organization Fund for PBC Water Taxi Facilities from Contributions to Other Governmental Agencies to transfer to Park Improvement Fund 3600; and C) approve a Budget Amendment of \$30,000 in the Park Improvement Fund to recognize the transfer from the Metro Planning Organization Fund.

Summary: On September 9, 2008, the Board approved a Grant Agreement (R2008-1526) with the MPO for \$100,000 for construction of a water taxi facility at DuBois Park, and authorized the County Administrator or his designee to execute all future time extensions, task assignments, minor amendments, and other necessary forms and certifications during the term of the Grant Agreement that do not change the amount of funding, scope of work, or terms and conditions of the Agreement and for the Director of the Parks and Recreation Department to serve as Liaison Agent with the MPO for this project. Two Amendments were subsequently entered into for this Agreement and executed by the Director of the Parks and Recreation Department serving as Project Liaison. These two Amendments extended the project completion date to December 31, 2009, and December 31, 2010, respectively, and clarified dates by which grant funds must be expended, invoices must be submitted for reimbursement, and when the water taxi docks must be completed and opened to the public. The Third Amendment is being presented to the Board for signature because it increases the funding amount of the grant from \$100,000 to \$130,000. The estimated project cost for the water taxi facility is \$130,000. No match is required for this grant. Funding is from the U.S. Department of Transportation, Ferry Boat Discretionary Program, through the State of Florida Department of Transportation, and is administered by the Palm Beach MPO. District 1 (AH)

Background and Justification: The water taxi facility at DuBois Park will replace one of four existing docks at Zeke's Marina with a six-foot wide ADA compliant gangway leading to a 10' wide by 34' long floating dock. Water taxis using the DuBois Park docking facilities will provide riders an alternative means of transportation for access to DuBois and Jupiter Beach parks for picnicking, fishing, beach access and snorkeling. The water taxi project is a part of the larger DuBois Park Marina and Shoreline Stabilization Project. The Grant Agreement requires County to maintain the water taxi facility and guarantee it is open and accessible to the public as a water taxi facility for no less than ten years or until March 31, 2021.

THIRD AMENDMENT TO GRANT AGREEMENT BY AND BETWEEN PALM BEACH METROPOLITAN PLANNING ORGANIZATION AND PALM BEACH COUNTY BOARD OF COUNTY COMMISSIONERS (RELATING TO DUBOIS PARK DOCK)

THIS THIRD AMENDMENT is made and entered into this ____ day of _____, 2010, by and between the Palm Beach Metropolitan Planning Organization, a Florida body politic created pursuant to Chapters 163 and 339, F.S. (hereinafter referred to as the "MPO") and Palm Beach County, a political subdivision of the State of Florida, by its Director of the Department of Parks and Recreation (P&R) for the Palm Beach County Board of County Commissioners (hereinafter referred to as the "Grantee").

WITNESSETH

WHEREAS, on September 9, 2008, the parties entered into a Grant Agreement (Agreement) under which the MPO agreed to make certain grant funds the MPO was eligible to receive under a Joint Participation Agreement (JPA) with Florida's Department of Transportation (FDOT) for the creation of a countywide water taxi transit system, available to Grantee for the purpose of reimbursing Grantee, up to an amount not to exceed \$100,000.00, for certain costs the Grantee would incur in the design, permitting and construction of improvements to an existing water taxi docking facility located in the DuBois Park Public Use Facility in Palm Beach County, Florida; and

WHEREAS, on the 15th of May 2009, the parties amended the Agreement to extend the completion date for the improvements to the water taxi docking facility and other related improvements to December 31, 2009, and thereafter amended the Agreement a second time to extend the completion date to December 31, 2010, and establish March 31, 2011, as the date the Facility would be open and accessible to the public; and

WHEREAS, the Grantee has advised the MPO that the cost to complete the improvements to the water taxi docking facility and bring it into compliance with Federal regulations will exceed the original grant amount and the Grantee has requested that the grant be increased to \$130,000.00; and

WHEREAS, the MPO has determined that it has sufficient funds available that can be used to increase the grant funds made available to the Grantee to a total grant amount of \$130,000.00.

NOW, THEREFORE, in consideration of the mutual terms, conditions, promises, covenants, and obligations set forth herein, the MPO and the Grantee agree as follows:

- 1. That Attachment B. Project Budget attached to the Agreement is replaced with a new attachment identified as "Attachment B. Revised Project Budget" which is attached to this Third Amendment. "Attachment B. Revised Project Budget" contains the revised project budget for the Project.
- 2. That Section 5. The Project, of the Agreement is amended to provide as follows:

Page 1 of 4

Section 5. The Project: The MPO has entered into a JPA with FDOT under which FDOT has agreed to provide Ferry Boat Discretionary Program (FBD) funds to the MPO to be used to assist with the first phase of a Countywide system to link cities by way of an integrated water taxi transit system. The Grantee has requested a grant of the FBD funds to be used to design, permit, and construct a docking facility at the DuBois Park site located in Jupiter, Florida (also referred to herein as the "Facility") as further described in Attachment A, Project Description, attached to the Agreement, as modified by "Attachment B. Revised Project Budget," attached to this Third Amendment. The MPO will make available up to One Hundred Thirty Thousand Dollars (\$130,000.00) in grant funds to be used to reimburse the Grantee for permissible Project expenses related to the design, permitting, and construction of the improvements to the Facility in accordance with "Attachment B. Revised Project Budget," attached to this Third Amendment. The Grantee shall utilize such grant funds in accordance with the terms and conditions of this Agreement, and all Federal State and local laws, rules and regulations that are applicable to the Project.

- 3. That Paragraph A of Section 8. Project Cost, Reimbursement and Submittal of Invoices, is amended to provide as follows:
 - A. The MPO will make up to One Hundred Thirty Thousand Dollars (\$130,000.00) in grant funds available to the Grantee, on a cost reimbursement basis. These funds shall be used by the Grantee solely for certain allowable expenses incurred by the Grantee in the performance of the Project. The MPO shall not reimburse Grantee for any expenses incurred by the Grantee prior to the Grantee having obtained all permits needed to commence and complete the work.
- 4. That Section 9. Grantee's Contribution, is amended to provide as follows:
 - Section 9. **Grantee's Contribution:** There is no local match required of the Grantee for this Project. Grantee acknowledges and agrees, however, that it is responsible for and will fund all costs to complete the Project in excess of the \$130,000.00 granted hereunder. In addition, Grantee is responsible for all of the ongoing costs and expenses of maintaining and operating the Facility and related improvements. Grantee shall insure that the Facility and related improvements are open and accessible to the public and used for the provision of water taxi services as contemplated in this Grant Agreement for a period of no less than ten (10) years and that the Facility, related improvements, and all means of access, ingress and egress thereto, are well maintained and operated in conformity with all Federal, State and local laws, rules and regulations.
- 5. This Third Amendment shall take effect upon execution by the parties.
- 6. Except as amended herein, all other terms of the Agreement, as previously amended, are hereby confirmed and shall remain in full force and effect.
